AGREEMENT ON PROJECT IMPLEMENTATION

(hereinafter referred to as the "Agreement")

between

Czech University of Life Sciences Prague

and

Agricultural Research Organization – Volcani Center

(hereinafter collectively referred to as the "Partners" or "organizations")

Czech University of Life Sciences Prague (hereinafter referred as "sending organization"), represented by, on the basis of a power of attorney, its first vice-rector prof. PhDr. Michal Lošťák, Ph.D. and Agricultural Research Organization , (hereinafter referred as "receiving organization") represented by Dr. Bernstein Nirit signed this Agreement to facilitate the implementation of the project "Supporting the development of international mobility of research staff at CULS Prague" (in Czech Podpora rozvoje mezinárodních mobilit výzkumných pracovníků ČZU v Praze; grant reg. no. CZ.02.2.69/0.0/0.0/16_027/0008366). This agreement is based on long-term mutual cooperation between these two organizations.

This Agreement on Project Implementation is intended to set the terms and conditions between sending organization and receiving organization in the period of implementing the project "Supporting the development of international mobility of research staff at CULS Prague (hereinafter referred as "the project") which also concerns the mobility of Ms. Ing. Anežka Janatová who was nominated after selection procedure by sending organization to carry out part of his/her research-oriented professional development at receiving organization. The project is funded by EU Structural and Investment Funds under Operational Programme Research Development and Education (managing authority Ministry of Education, Youth and Sports, Karmelitská 7, 118 12 Praha 1, Czech Republic).

Objectives of Agreement on Project Implementation:

- 1. With the support of EU funding to collaborate in the implementation of the project in order to improve the quality of science and research at the Czech University of Life Sciences Prague.
- 2. With the support of EU funding to facilitate in the mutual transfer of good practices in science and research between both sending and receiving organizations.

Above mentioned goals will be achieved under following terms and conditions:

 Receiving organization will provide an academician of the Czech Universitγ of Life Sciences Prague Ms. Ing. Anežka Janatová a possibility to conduct her mobility in the facilities of receiving organization for the period from October 2018 until April 2019. Total time of the mobility of Ms. Ing. Anežka Janatová at receiving organization is 6 months. Ms. Ing. Anežka Janatová has a duty to work at least 6 months after the end of mobility at sending organization.

- 2. Sending organization will provide Ms. Ing. Anežka Janatová and her family the funding to support expenses incurred during the mobility at receiving organization according to the rules set in the call for the project by managing authority Ministry of Education, Youth and Sports, Karmelitská 7, 118 12 Praha 1, Czech Republic. These expenses are funded by the project implemented within Operational Programme Research Development and Education managed by the Czech Ministry of Education, Youth and Sports and are calculated according to terms and conditions defined in the call for projects. The funding must be used by Ms. Ing. Anežka Janatová to conduct the mobility only. No other funding can be provided by receiving organization.
- 3. Receiving organization agrees with the time schedule and activities of the mobility of Ms. Ing. Anežka Janatová at receiving organization. The time schedule and activities of the mobility form an appendix to this Agreement on Project Implementation.
- 4. Sending organization and receiving organization have agreed and declare that all activities implemented under the project by Ms. Ing. Anežka Janatová from sending organization will be only of non-economic nature (in accordance with Communication from the Commission "Framework for State aid for research and development and innovation (2014/C 198/01)", paragraph 19).
- 5. In a case of a post-doc mobility the receiving organization appoints the mentor Dr. Nirit Bernstein whose H-index is 27 at least and who published at least 3 papers registered in Web of Science or Scopus within last 5 years and/or coordinated at least one international or national research project within last 5 years.

This Agreement on Project Implementation is at-will upon signature by the authorized representatives from sending organization and receiving organization. This Agreement shall become in effective on the date of its publication in the register of contracts in accordance with Act No. 340/2015 Coll., on register of contracts, as amended. The Agreement on Project Implementation might be terminated by any one of the partners following mutual consent and is terminated by the end of mobility of Ms. Ing. Anežka Janatová at receiving organization. The Agreement on Project Implementation can be modified after mutual consent of sending organization and receiving organization as the Amendment to this Agreement on Project Implementation.

Receiving organization unreservedly agrees to the publication of the full text of the Agreement so that this Agreement may be the subject of the information provided within the meaning of Act No. 106/1999 Coll., On Free Access to Information, as amended and published pursuant to Act No. 340/2015 Coll., on the register of contracts, as amended.

The Partners declare that before signing hereunder they have read the Agreement and unreservedly agree to its contents. The Agreement is an expression of their true, genuine,

free and serious will. The proof of the authenticity and veracity of these statements to be provided by the authorized representatives of the Partners in the form of their signatures.
