Hereinafter individually or collectively referred to as the "Party" or the "Parties".

WHEREAS

ECRIN PARTNER and ECRIN entered into an agreement (Agreement_DISCHARGE_ECRIN_Masaryk University, Czech Republic, Version 01_03072017) (the "Agreement") for the performance of Clinical trial entitled DISCHARGE.

The Clinical trial is the core part of the **DISCHARGE Project** of an European Consortium which receives funding from the European Union H2020 programme under Grant Agreement no. 603266.

The Agreement between the Parties will expire on **November 30th, 2018**, and the Parties want to extend the aforementioned Agreement for an additional term commencing upon the expiration of the original term and shall now expire on **January 31st, 2019** (Termination date).

In addition, due to the patient shift and increased monitoring activities, the Parties want to modify the aforementioned Agreement as follows:

1. The Appendix 2: Price and payments (Agreement Version 01_03072017) of the agreement is modified and replaced by Appendix 2: Price and payments (Agreement Version 02_23) as described below:

The following words shall be added at the end of Appendix 2 (Agreement Version 01_03072017), after the Budget (price list) table:

"Additional Monitoring visits (MV) might be requested but would depend on the Sponsor decision. Any additional MV will then need to be approved by ECRIN and the Sponsor and will be invoiced (same cost as the other visits, i.e. 704 EUR per one MV) after the confirmation receipt of monitoring report of the performed visit".

All other terms and conditions of the Agreement shall remain in effect and unchanged.

ECRIN acknowledges that the ECRIN PARTNER is an obligated subject under the Czech act no. 340/2015 Coll. of the Czech Republic, on special conditions for the effectiveness of some contracts, the disclosure of these contracts and the Registry of contracts (Act on the Registry of contracts). Provisions of the Act on the Registry of contracts obligates public institutions (such as Masarykova univerzita) to transparently publish a copy of this amendment in a central repository of contracts (Registry of contracts) before the amendment enters into force.

The First Amendment is considered concluded as from the date of signature of the last Party to sign the amendment. The effective date is the date when a copy of this amendment has been published in the Registry of contracts.
