

THIS AGREEMENT is between Czech Republic – The Ministry of Defence, “Licensee and The PRS Group, Inc., “Licensor,” a firm incorporated in the state of New York and operating at the following address: 5800 Heritage Landing Drive, Suite E, East Syracuse, NY 13057.

IN CONSIDERATION OF the mutual promises set forth below, Licensor and Licensee agree as follows:

1. Definitions.

- a. “**Authorized User**” means the Licensee named above and as further defined in Attachment A.
- b. “**Authorized Site**” means a geographically contiguous office building, complex or campus location within Licensee’s control.
- c. The “**Licensed Product(s)**” means each licensed electronic publication/database including, if applicable, accompanying software as named herein on Attachment A.

2. License. Licensor hereby grants to Licensee the right to use the licensed product(s) in accordance with the terms and conditions of this Agreement. Licensor represents and warrants that it has the right to grant this license and that use of the licensed product(s) in accordance with the terms of this agreement will not infringe the intellectual property or other rights of any third party. The copyright and other proprietary rights in the licensed product(s) remain the sole and exclusive property of the Licensor. The licensed product(s) is intended and authorized for use only at the Authorized Site and only by Authorized Users. Licensee shall use reasonable efforts to protect the licensed product(s) from being copied and from any other use that is not permitted under this agreement. No part of this licensed product(s) may be duplicated in hardcopy or machine-readable form without prior written authorization from Licensor, except as provided below. Licensee shall use the licensed products only at one Authorized Site, and shall not connect the licensed products to a network that permits use anywhere other than that Authorized Site.

- a. Updates. Licensee holding a subscription, as clarified in Paragraph 4. Term, will receive whatever updates to the licensed product that are issued during the one-year period of this agreement and thereafter, only if the subscription and this agreement are extended, as clarified in paragraph 4. If this license covers a product that does not include a subscription, Licensee will not receive any updates to the licensed product.
- b. Archival Copy. Upon termination of this agreement, Licensee may retain one copy of any CD-ROM, diskette or other fixed media licensed product(s) for archival purposes. This archival copy of the licensed product(s) does not entitle the Licensee to any updates of the material.
- c. Specific Performance. In the event of a breach of either of the preceding two provisions, Licensor shall be entitled to all available remedies to the fullest extent permitted by law.

3. Warranties.

- a. Online System. Licensor shall use reasonable efforts to provide continuous availability of an online database related to this license, subject to periodic unavailability due to maintenance of the server(s), the installation or testing of software, the loading of data and downtime related to equipment or services outside of control of the Licensor.
- b. Fixed Media. Additionally, Licensor shall promptly replace at no cost to the Licensee all or part of the database which is defective or does not conform with this agreement, provided that the Licensee gives the Licensor written notice of the nonconformity, defect, or damage within sixty (60) days after Licensee’s receipt of the copy. Without such notice, Licensor shall make replacement at the Licensor’s replacement cost.
- c. **DISCLAIMER. EXCEPT FOR THE EXPRESS WARRANTIES STATED IN THIS AGREEMENT,**

THE DATABASE IS PROVIDED ON AN AS-IS BASIS AND LICENSOR DISCLAIMS ANY AND ALL OTHER WARRANTIES OF ANY KIND, EXPRESSED OR IMPLIED, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

4. Term. This license shall begin on the date of the last signature on this agreement and shall be valid until June 30, 2017. If Licensed Product includes a subscription and Licensee renews that subscription, this license and all of its provisions will automatically extend until Licensee cancels the subscription at the end of a subsequent term, or until the license is terminated under the provisions of paragraph 5. If Licensed Product does not include a subscription, Licensee can extend this license for one year by purchasing updates to the Licensed Product.

5. Termination. If Licensee breaches any provision of this Agreement, in addition to any rights or remedies, PRS may terminate this Agreement without prior notice. The provisions set forth in Sections 2, 5, 6, and 7 shall survive the term of this Agreement and shall continue in force and perpetuity.

6. Prices and Payments.

a. Prices applicable to Licensed Product(s) are as published in PRS' then-current price list(s), or as agreed in writing with Licensee. Licensor's invoices are due upon receipt. Payments will be in accordance with the terms and conditions of this agreement and with those included on every invoice and renewal notice delivered by Licensor to Licensee. Licensee shall be liable for all costs of collection, reasonable attorney fees and court costs if Licensor shall find it necessary to collect delinquent payments and/or enforce any other rights or remedies available. Failure or delay in rendering payments due under this Agreement constitutes a material breach of this Agreement. In addition to any other rights and remedies available to Licensor resulting from Licensee's breach hereof, Licensor may retain any deposit of Licensee.

b. The published prices of Licensor's products are exclusive of sales, use, excise or other similar taxes and any such present or future applicable taxes on the sale of services and/or products hereunder shall be paid by the Licensee.

c. If the licensed product includes a subscription, as clarified in 4. Term, it will renew automatically unless Licensee notifies Licensor thirty (30) days prior to expiration date.

7. Miscellaneous.

a. **Entire Agreement.** This agreement contains the entire agreement of the parties as to herein licensed use of the database and supersedes any and all written or oral prior agreements and understandings. This agreement may only be amended or modified in writing signed by the parties.

b. **Assignment.** This agreement may not be assigned by either party without the prior written consent of the other.

c. **Notices.** Any notice provided in this agreement shall be sent by personal delivery or by certified mail, postage prepaid, to the other party at its address set forth herein or such other address as shall have been communicated in writing to the other, and shall be effective as of its personal delivery or mailing date, as the case may be.
