1. In accordance with the Article XVIII. (4) of the Purchase Agreement (No. 198/2018) concluded on November 20<sup>th</sup>, 2018 (hereinafter referred to as the "**Purchase Agreement**") the Contracting parties have agreed upon the following changes to the Purchase Agreement:

a) Article V. (2) of the Purchase Agreement is replaced by the following:

“2. Price of the Subject of the Contract:

<b>Subtotal: Total price for guaranteed part of the subject of performance (i.e. the aforementioned parts of the subject of performance)</b>	<b>EUR 224 468, 61 excl. VAT</b>
f) <i>Components for modification of equipment for cutting data pages, including installation (reserved change of obligations pursuant to Section 100 (1) of the Act, which is not guaranteed by the Contracting Authority, based on the conditions of Article XVII hereof)</i>	<b>EUR 86 230,09 excl. VAT</b>

2. The other provisions of the Purchase Agreement and the Annexes to the Purchase Agreement are not changed.

1. This Amendment No. 1 is drawn up in the English and Czech languages, always in two copies with the validity of the original, each of the Contracting Parties will receive one copy of both language versions.
2. The Seller take note that this Amendment No. 1 could be, in accordance with Act No. 340/2015 Coll., on Special Conditions of Efficiency of some Contracts, Disclosure of such Contracts and the Contracts Register (the Contracts Register Act), after its signing,

disclosed in the Contracts Register. The disclosure and related operations shall be ensured by the Buyer.

3. This Amendment No. 1 comes into validity on the day of signature by both Contracting Parties and into effect after disclosing in the Contracts Register.
