(the Licensee and the Licensor hereinafter also jointly the “Contracting Parties” and each separately also the “Contracting Party”)

1. INTRODUCTORY PROVISIONS

1.1. On 21st June 2018, the Contracting Parties entered into the Standard License Agreement which define conditions of cooperation and rights and duties of the Contracting Parties while providing defined Licensed Materials that are set forth in Appendix A to the Licensee and Participating institutions listed in Appendix B (Participating Institutions & Fees) (hereinafter referred to as the “Agreement”).

1.2. Because of demand of one of the Participating Institution - Institute of Physics of the CAS to have access to the RSC Gold Collection, the Contracting Parties

execute this Amendment. Furthermore, the Contracting Parties wish to specify certain parts of the Agreement and change some provisions.

2. SUBJECT-MATTER OF THE AMENDMENT

2.1. The Contracting Parties have agreed that Appendix A: Licensed Materials to the Agreement shall be modified so that part 1. Association for Computing Machinery (ACM) shall be replaced as a whole by the following:

Licensed Material: ACM Digital Library

- **List of contents of the ACM Full-Text Collection and Dates covered:** see https://dl.acm.org/contents_dl.cfm
- **Description:**

ACM Digital Library subscription access includes: i) ACM Publications including: over 50 peer-reviewed scholarly journals; 8 technical magazines, ACM's complete collection of conference proceedings containing over 2,500 volumes of scholarly materials; and 37 technical newsletters sponsored by ACM's technical Special Interest Groups (SIGs), and ii) ACM Guide to Computing Literature, ACM's bibliographic database and abstracting & indexing service. The publications referenced herein do not include the ACM Books Collection I content (<http://books.acm.org/>), which is available for separate one-time purchase.

Access to Historical Archive. The Publisher shall provide complimentary access to the complete archive of all ACM Publications dating back to each publication's first issue or volume. This complimentary access does not include archival rights, which can be arranged by separate Agreement

Agreement Term: Effective date - 31 December 2020 + optional 1 January 2021 - 31 December 2022

Access Conditions: Unlimited simultaneous access (no perpetual rights!)

Authentication: IP authentication (See Appendix C for IP addresses)

2.2. The Contracting Parties have agreed that Appendix B: Participating Institutions & Fees to the Agreement shall be modified

2.3. The Contracting Parties have agreed that article 6. Of Appendix E: Payment Terms to the Agreement shall be replaced as follows:

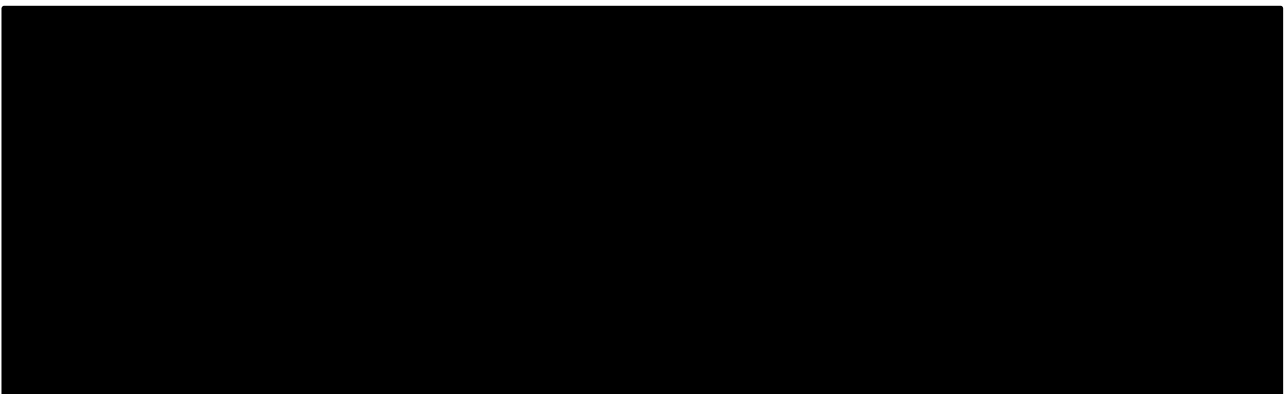
- The invoice shall be issued in the currency specified in the Agreement. In the event that there are multiple currencies specified in the Agreement for each Licensed Material, the Licensor shall issue at least the number of invoices corresponding to the number of currencies. The foreign currency on the invoice(s) shall also be converted into Czech crowns according to the Czech National Bank exchange rate (www.cnb.cz) on the date of the taxable transaction.

3. FINAL PROVISIONS

- 3.1. The Amendment shall enter into force on the date of signature by both Contracting Parties. The Amendment comes into effect on the date of its publication in the Register of Contracts under the conditions stipulated by Act No. 340/2015 Coll., On the Register of Contracts. The Amendment will be published by Licensee in the Register of Contracts.
- 3.2. All other provisions of Agreement shall remain unaffected.
- 3.3. The Amendment is compiled in three counterparts in the English language, each of which has the power of an original. Licensor shall receive one counterpart and Licensee shall receive two counterparts.
- 3.4. The Contracting Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and affect under law.
