# **Memorandum of Understanding**

# **Manipal University Jaipur**

and



**University of Ostrava** 

The Parties, Manipal University Jaipur, a State Private University established vide the Manipal University Jaipur Act 2011 (Act No. 21 of 2011), having it's campus at Village Dehmikalan, Tehsil Sanganer, Off Jaipur Ajmer Expressway, Near GVK Toll Plaza, Ajmer Road, Jaipur 303007 Rajasthan, India, represented through it's Registrar Prof. (Dr.) Vandana Suhag, (hereinafter referred to as "MUJ")

#### And:

University of Ostrava, public university established by the law no. 314/1991 Coll., as amended, with registered address Dvořákova 7, 701 03, Ostrava, represented through the Rector prof. MUDr. Jan Lata, CSc., (hereinafter referred to as "UO")

enter jointly into a memorandum of understanding to establish a basis for collaboration and exchange in areas of interest and benefit to the respective institutions.

I.

The Purposes of this Memorandum of Understanding between MUJ and UO are as follows:

- promote institutional exchange through mobility of academic, research and administrative personnel of the partner institutions to participate in a variety of teaching, research and professional development activities;
- promote interest in the teaching and research activities of the respective institutions:
- seek opportunities to receive students on exchange of the partner institution
- seek opportunities for joint research projects;
- seek to develop double-degree programmes between the respective institutions;
- seek to develop short term and long term trainings for respective students and academic staff;
- organize symposia, conferences, short courses and meetings on research and academic issues.

II.

This general Memorandum of Understanding shall be identified as the parent document of any further agreements executed between the Parties. Further agreements concerning any program shall provide details concerning the specific commitments made by each signatory Party to the further agreement, and shall not become effective until they have been reduced to writing and executed by the duly authorized representatives of the concerned Parties.

This Memorandum of Understanding implies no financial obligation on either signatory Party. The scope of the activities under this Memorandum of Understanding shall be determined by the funds regularly available at the respective institutions for the respective type of collaboration undertaken and by financial assistance, which may be obtained by the respective Party from internal or external sources.

Except as may be stipulated in any specific program agreement, each Party shall be responsible for expenses incurred by its employees under this Memorandum of Understanding.

#### IV.

The University of Ostrava is an obliged entity pursuant to Act No. 340/2015 Coll., Act on the Register of Contracts (hereinafter the "Act on the Register of Contracts"). The Manipal University in Jaipur acknowledges and expressly agrees that this Agreement in full is subject to publication in the Register of Contracts (public administration information system administered by the Czech Ministry of the Interior). The University of Ostrava undertakes to publish this Agreement in compliance with the provisions of the respective Act on the Register of Contracts.

This Agreement comes into force upon signature by both parties and becomes effective on the date of its publication in the Register of Contracts at the earliest. About this fact, the University of Ostrava is required to notify Manipal University in Jaipur.

Upon approval by each Party, this Memorandum of Understanding shall remain in effect for a period of five (5) years unless terminated earlier by a Party, and will renew automatically unless terminated. Such termination by one institution shall be effected by giving the other institutions at least ninety (90) days advance written notice of its intention to terminate. If such notice is given, this Memorandum of Understanding shall terminate: (a) at the end of such ninety (90) days; or (b) when all students enrolled in a course of study under the Memorandum of Understanding have completed that course of study, whichever event occurs last. Termination shall be without penalty. If this Memorandum of Understanding is terminated, neither MUJ nor UO shall be liable for the other's losses that may result.

In case any dispute arises due to any of the terms and conditions of this MoU or interpretation thereof, the same shall be resolved amicably through mutual discussions.
