2. Preamble of the Amendment

- 2.1 On October 6, 2016 the Parties signed the Contract for Work (Contract No. ANS CR 124/2016/IS/173) (hereinafter referred to as the "Contract for Work") the subject of which is supply and installation of the upgrade of "A-SMGCS" on existing A-SMGCS System.
- 2.2 The Parties hereby agree to conclude this Amendment No. 3 to the Contract for Work which contains additional requirements:
 - a) VO-18 ASTERIX CAT062 Item 390 Callsign Handling
 - b) Software change request from ANS CR: Do not show frame around the label when cursor is hovering over the label
 - c) Software change request from ANS CR: Uniform layout of OK/Close buttons in ASMGCS CWP dialogues and opening dialog close to cursor position.
 - d) Software change request from ANS CR: Height filter shall be applied for both track symbol and label
 - e) Software changes requested from ANS CR: Toolbars Free space between the groups
 - f) Software changes requested from ANS CR: Label priority issue

Appendix to Amendment no 3: VO-18 ASTERIX CAT062 Item 390 Callsign Handling

2.3 These additional requirements modifies the Contract for Work as follows:

3. Subject of the Amendment No 3

- 3.1 Article 4 "Terms of Performance" shall be modified in paragraph 4.1 of the Contract for Work as follows:
- "4.1 The Contractor shall handover the additional requirements specified in Appendixes No 7-16 and 18 to the Client latest by:

SAT2 March 31, 2019".

- 3.2 Article 12 "Contractual Penalties" shall be modified in paragraph 12.1 of the Contract for Work as follows:
- "12.1 If the Contractor fails, for reasons other than causes beyond its control, to perform the Work within SAT2 term under Article 4 of the Contract, then the Client may claim from the Contractor a penalty equal to 0,05 % of the price specified in Article 3 above per each day of delivery."
 - 3.3 Article 6 "Taxes" shall be modified in paragraph 6.3 of the Contract for Work as follows:
- "6.3 The Client declares that its registered as a VAT payer in the Czech Republic under registration number CZ699004742."

4. Final Provisions of the Amendment No. 3

4.1 All the other parts of the Contract for Work shall not be changed by this Amendment No 3.

4.2 Publication

The Contractor acknowledges that the Client is obliged to publish this Amendment No 3 pursuant to the Act No. 340/2015 Coll., on the Register of Contracts, as amended. The Contractor also acknowledges that the Client is obliged to provide information pursuant to the Act No. 106/1999 Coll. on Free Access to Information, as amended. When this Amendment No 3
