In order for Licensee to comply with the Act on Registration of Agreements, WDCL shall provide Licensee with a Redacted Version of this first amendment sent via email in order for such Redacted Versions to be disclosed. The “**Redacted Version(s)**” in each case shall mean a copy of this first amendment with the following provisions redacted (i.e. blacked-out):
- (i) Paragraphs 1 and 2 of this first amendment in their entirety (with the exception of heading of the paragraphs);
 - (ii) Exhibits A and B in their entirety (with the exception of Total License Fee); and
 - (iii) Any reference to the programming licensed hereunder.
10. **Effective Date:** The Effective Date of this first amendment shall be 29 October 2018.
11. **Definitions:** All definitions used herein shall have the meanings ascribed to them in the Agreement unless expressly stated otherwise.

12. **Ratification:** Except as expressly varied hereby, the Agreement is hereby ratified and all terms and conditions of the Agreement shall remain in full force and effect.

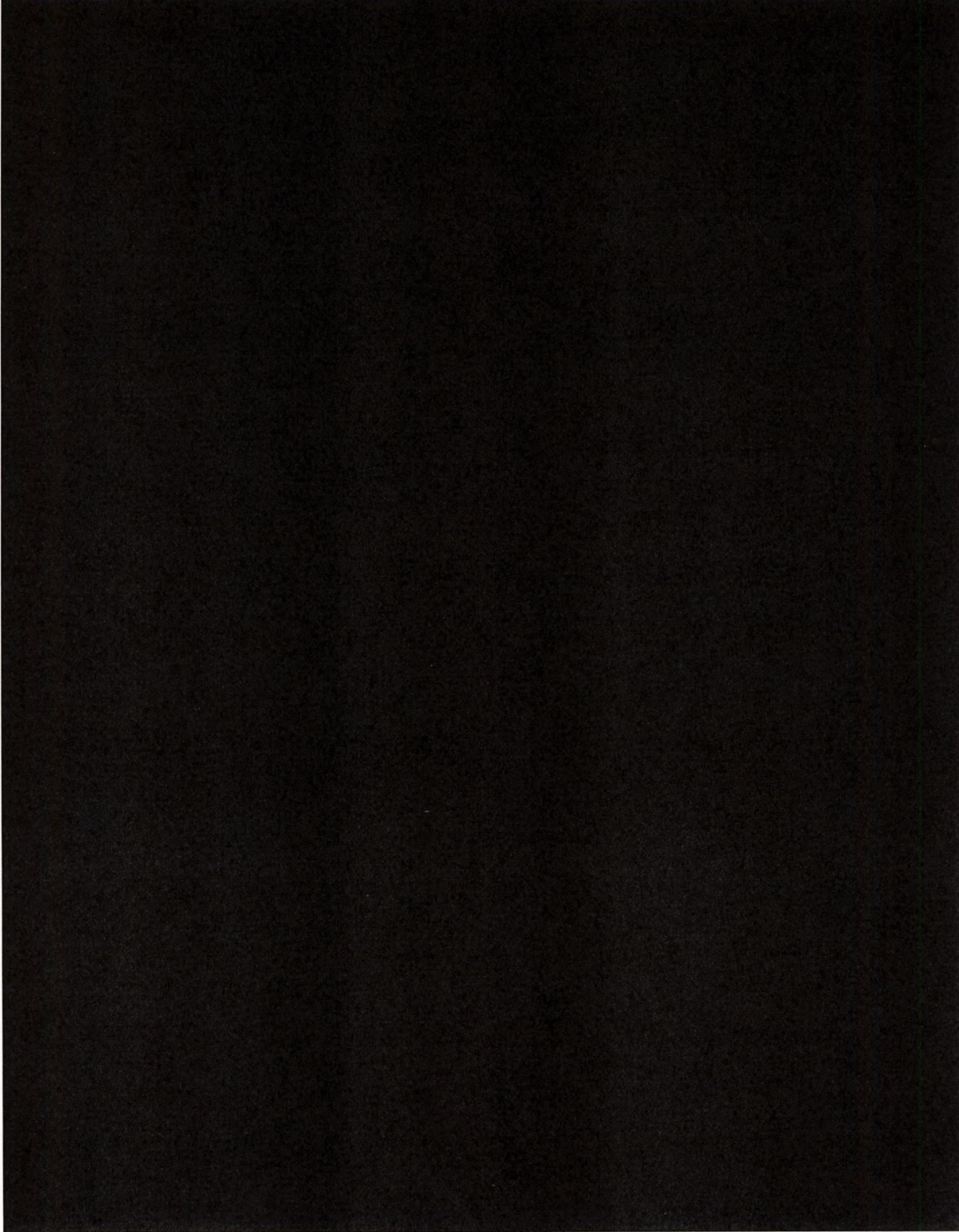

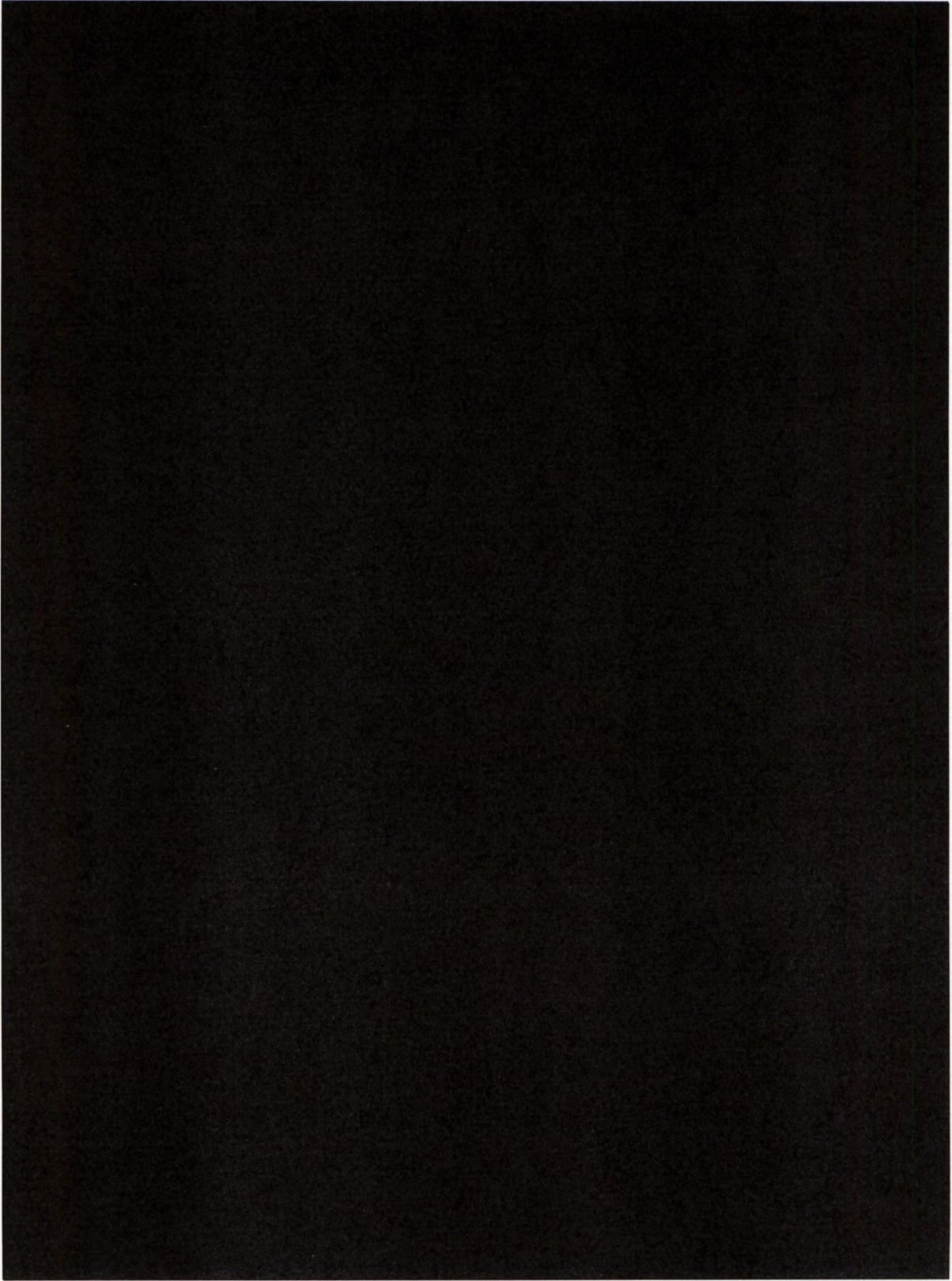

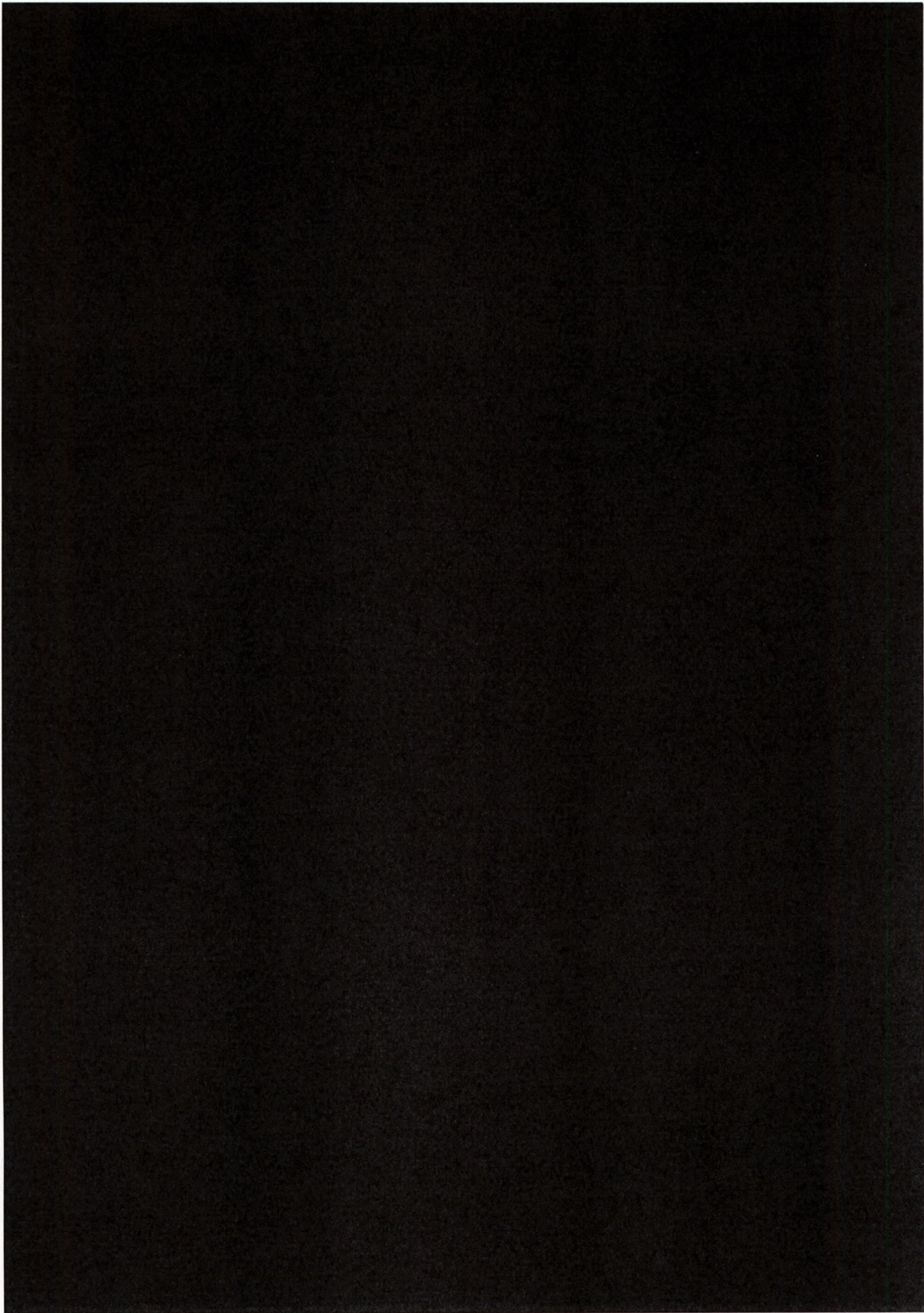
