#### 1. PREAMBLE

#### 2. SUBJECT

2.1. The License Agreement shall be amended by changing the following articles:

*"10. Duration of Obligations under this Agreement*

*10.1. This Agreement is entered into for 20 ("twenty") years since the effectiveness of this Agreement."*



**3. FINAL PROVISIONS**

- 3.1. The offer to enter into this Amendment (the offer) cannot be accepted by a reply with a reservation or deviation, which substantially alters the conditions of the offer.
- 3.2. This Amendment shall come into effect under Act No. 340/2015 Coll., on special conditions for the effectiveness of some contracts, the disclosure of these contracts and the register of contracts on the day of insertion into the registry of contracts.
- 3.3. Obligations arising out of this Amendment shall be governed by Czech law.
- 3.4. This Amendment is executed in two counterparts, each of which has the force of the original. Each **Contracting Party** shall receive one copy.
- 3.5. The **Contracting Parties** declare that they have carefully read this Amendment and that its contents are clear and understandable to them. In witness that the entire contents of this Agreement are a manifestation of their true and free will, the **Contracting Parties** attach their respective signatures.


