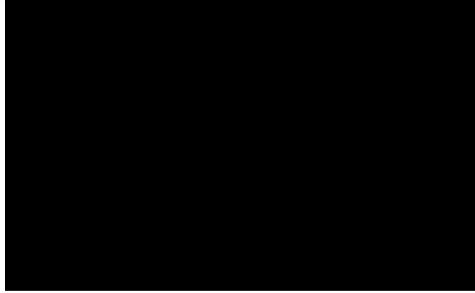

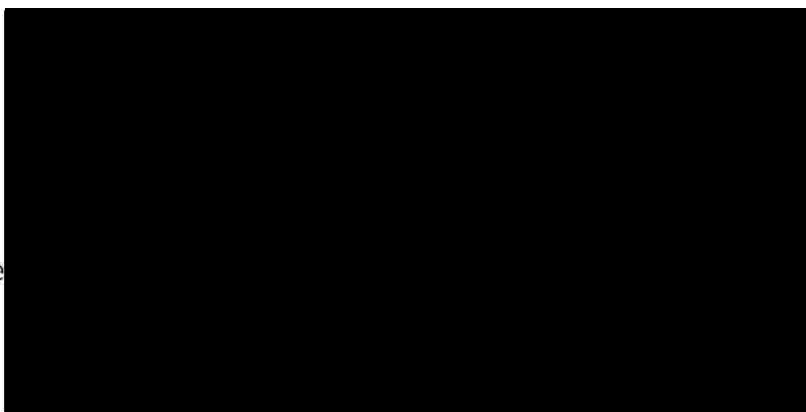

Whereas by letter of 14/08/2018 the coordinator has requested an amendment of the Agreement,

Whereas the Agency agrees to amend the Agreement,

As a consequence. the Agreement is modified as follows:

## ARTICLE I

**ARTICLE I.2 – ENTRY INTO FORCE OF THE AGREEMENT AND DURATION OF THE ACTION** of the Agreement shall read as follows:

I.2.1 The agreement shall enter into force on the date on which the last party signs.

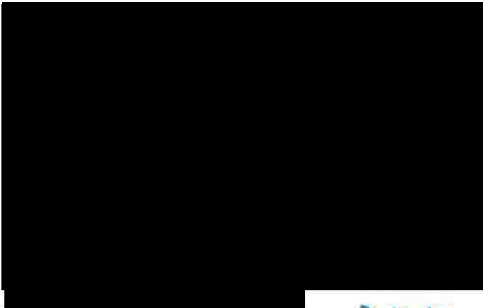
I.2.2 The action shall run as of 15/10/2015 (the "starting date of the action") and shall end on 14/04/2019.
