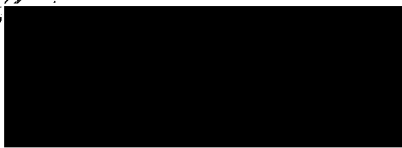


- a provision that the Additional Insured is not liable for the payment of any premium

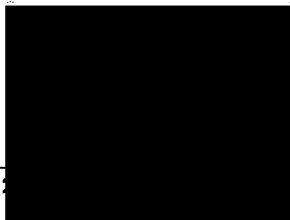
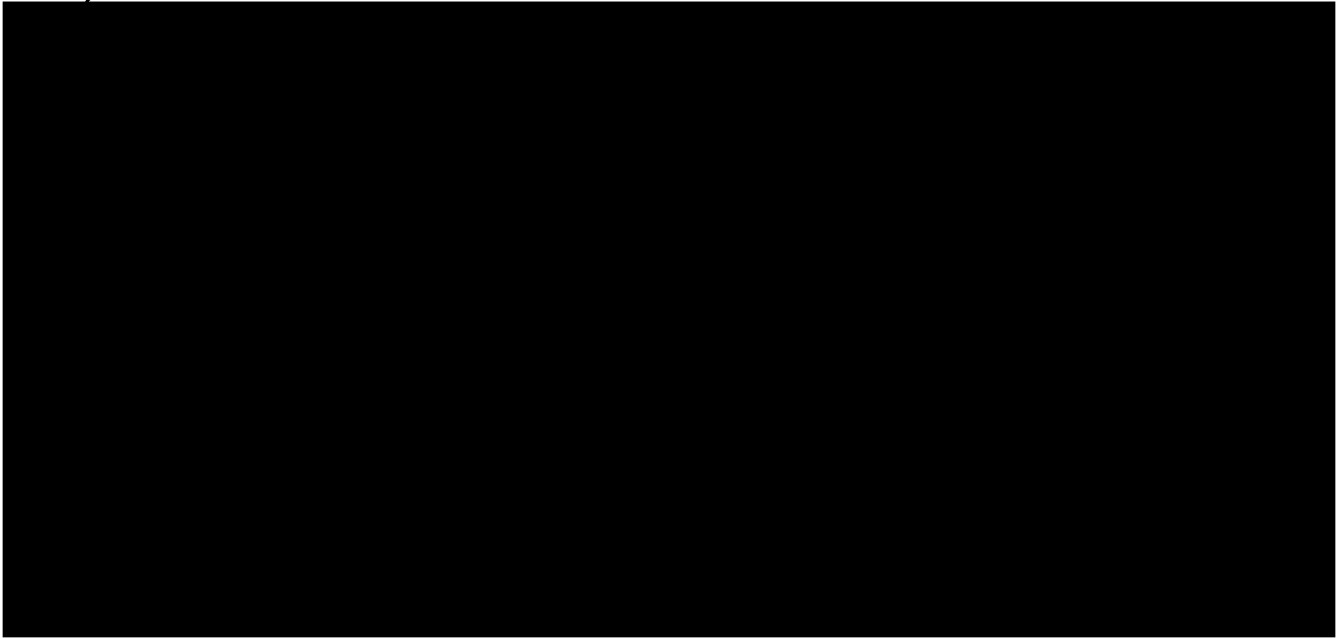
