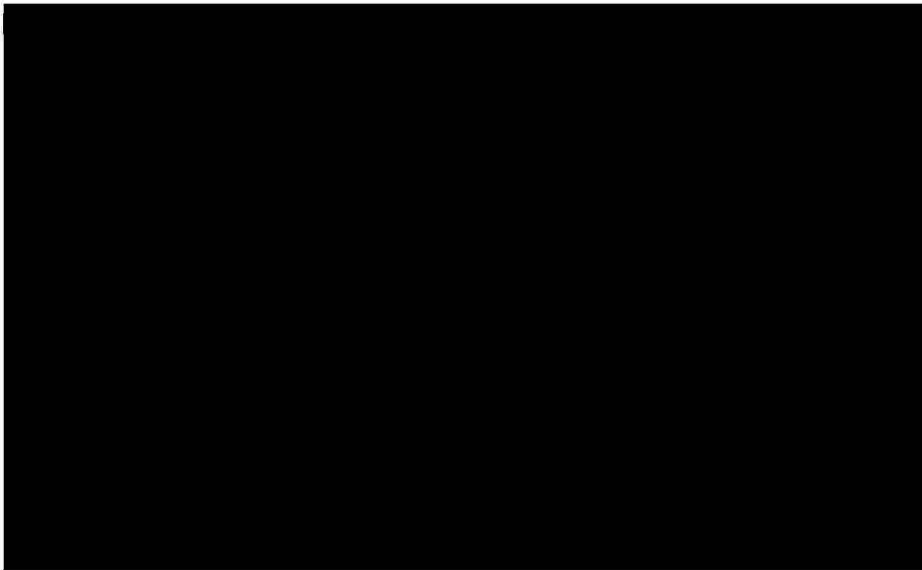


Annex No. 2 - Price of Commercial Letter Services agreed for a period from 01.01.2019 to 31.12.2019

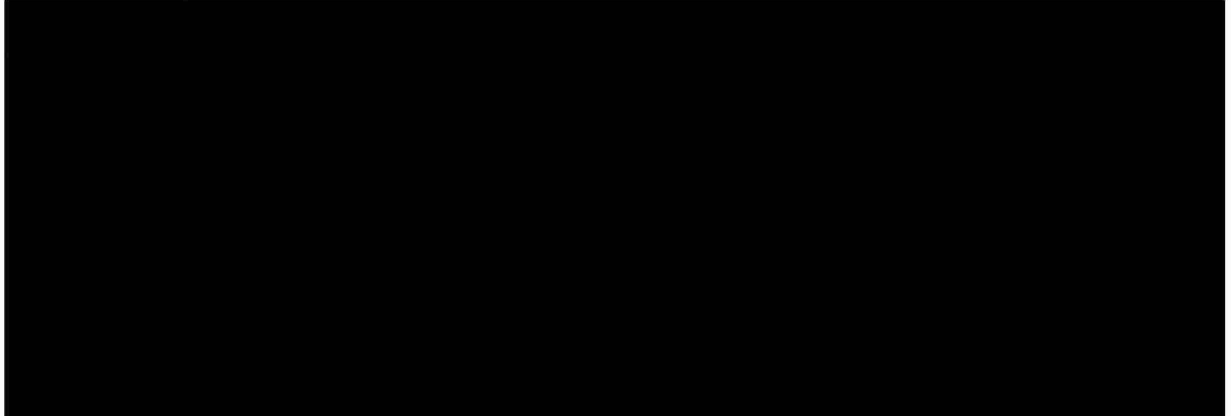
- 1.1 This Annex No. 2 (hereinafter referred to as “the Annex”) to the Agreement on the Conditions for Posting Commercial Letter Consignments [REDACTED] (hereinafter referred to as “the Agreement”) sets the price for all Commercial Letter consignments posted by the Consignor under the Agreement in the period from 01.01.2019 to 31.12.2019 (hereinafter referred to as “the Agreed Period”). The price is set in accordance with the Postal Terms and Conditions of Česká pošta, s.p. - Pricelist of Basic Postal Services and Other Services (hereinafter referred to as “the Pricelist”).
- 1.2 The expected volume of Commercial Letter consignments (hereinafter referred to as “the [REDACTED]”) to be [REDACTED] the [REDACTED] as part of an unspecified job in the Agreed Period exceeds [REDACTED] therefore, the basis for the running price charged for the unspecified job (a job which does not fulfil the conditions defined in subclause 1.4.1) is the price mentioned in this subsection below.



- 1.3 The Parties agree that after the end of the Agreed Period, a final settlement of accounts will be made according to the actual volume of Consignments posted by the Consignor as part of the unspecified job during the Agreed Period. If the volume of Consignments posted as part of the unspecified job during the Agreed Period does not exceed the minimum volume of 100 thousand Consignments, the difference between the above-mentioned price and the price specified in the Pricelist valid as of the day of posting of the Consignment will be charged. ČP will issue an invoice - tax document by the 15th day of the second month following the end of the Agreed Period; the invoice will be due 14 days from the date of issue.
- 1.4 The expected volume of Consignments to be posted by the Consignor as part of a [REDACTED] which fulfils the conditions defined in subclause 1.4.1) in the Agreed Period [REDACTED] and the Consignor agrees to fulfil the conditions specified in subclause 1.4.1; therefore, the basis for the running price charged for the specified job is the price mentioned in subsection 1.4.2

for specified jobs with the volume of posted consignments from 250 thousand Consignments to 500 thousand Consignments.

The above-mentioned prices only apply if all conditions mentioned in subclause 1.4.1 are fulfilled.

1.5 The Parties agree after the end of the Agreed Period, ČP will check the actual volume of consignments posted by the Consignor in the Agreed Period and fulfilment of the conditions mentioned in subclause 1.4.1 above, and issue a corresponding invoice or credit note as follows.

The Consignor agrees that:

- If the minimum volume of [REDACTED] posted as part of the specified job in the Agreed Period has not exceeded [REDACTED], the Consignor will pay to ČP on basis of an issued invoice - tax document for Consignments posted as part of the specified job and charged under this Annex the difference between the basis for running price and the price according to the Pricelist valid as of the date of posting of Consignments,
- If the minimum volume of Consignments posted as part of the specified job in the Agreed Period has exceeded [REDACTED] and any of conditions of the specification mentioned in subclause 1.4.1 above has not been fulfilled, the Consignor will pay to ČP on basis of an issued invoice - tax document for Consignments posted as part of the specified job and charged under this Annex the difference between the basis for running price and the price specified under subclause 1.2 for an unspecified job and the corresponding weight of Consignments,
- If the conditions 1 – 5 of the specification mentioned in subclause 1.4.1 above has been fulfilled and the minimum volume of Consignments posted as part of the specified job in the Agreed Period has not exceed [REDACTED] the Consignor will pay to ČP on

basis of an issued invoice - tax document for Consignments posted as part of the specified job and charged under this Annex the difference between the basis for running price and the price specified under subclause 1.4.2 for the corresponding volume.

ČP agrees that if the conditions mentioned in subclause 1.4.1 are fulfilled and the volume of Consignments posted during the Agreed Period [REDACTED] it will pay to the Consignor according to subclause 1.4.2 on basis of a credit note the difference between the already invoiced price (basis for running price) and the price which under this Annex corresponds to the actual volume of Consignments posted during the Agreed Period.

1.6 The Consignor agrees to maintain confidentiality of the entire text of this Annex (hereinafter referred to as "confidential information"), i.e. agrees not to disclose their content to a third party or give a third party any other possibility of access to such confidential information. The Consignor agrees to take reasonable care to protect confidential information from unauthorized use, provision, publication or dissemination. The Consignor agrees to make every effort that could be fairly required for the confidentiality of information being consistently maintained by the Consignor's employees. Providing access to confidential information to state authorities, attorneys-at-law, tax advisors and/or auditors does not constitute a violation. The Parties expressly agree that the Consignor's duty to protect confidential information under this Annex as well as the right to payment of a contractual fine under subclause 1.7, will survive the term of validity and effect of this Annex and will last until the time when the information becomes generally known otherwise than by violation of a duty of the Consignor.

1.8 The Parties will agree on a new Annex to cover the period next to the period mentioned in subclause 1.1 above. Should the Parties fail to agree on a new Annex at the latest by the end of the period mentioned in subclause 1.1 above, the price charged for the services during this subsequent period will be as quoted in the Pricelist valid as of posting date; the Pricelist is available at each post office in the Czech Republic and at the website <http://www.ceskaposta.cz/>.

1.9 The prices in the text of this Annex are quoted exclusive of VAT. VAT at the current rate will be added to the service price. The Consignor is obliged to pay the price with the added VAT.
