The order, i.e. the Proposal and its Acceptance Form, including the acceptance by the offeree, having the value of the subject exceeding 50.000 CZK excluding VAT, will be published in accordance with the Act No. 340/2015 Coll. on special conditions of effect of certain contracts, the publication of these contracts and the register of contracts (as amended).

In case of acceptance of the current Proposal by the offeree, the contract enters into effect at the moment of its publication in the register of contracts.

The offeror, who shall ensure publication of the contract in the register of contracts, shall inform the offeree of its publication forwith thereafter using the e-mail specified in the sponsorship proposal acceptance form.

The offeror and the offeree undertake to refrain from provision of whatever performance herunder prior to its effective date.

The contractual parameters of the current contract can be modified only in an identical way as the current Proposal and Acceptance was executed.
