the Agency has decided to amend the Grant Decision as follows:

ARTICLE I

i. The description of the action has been modified and contains complementary activities. Annex I (Complementary Description of the Action) of the present amendment complements Annex I of the Grant Decision. Annex I is attached to this amendment.

ii. The budget has been modified. Annex II (Revised Budget of the Action) of the present amendment replaces Annex III of the Grant Decision. Annex II is attached to this amendment.

iii. **ARTICLE 2 – ENTRY INTO FORCE AND IMPLEMENTATION PERIOD** of the Grant Decision shall read as follows:

2.1 The Grant Decision shall take effect on the date of its notification to the beneficiary.

2.2 The action runs for **15 months** starting on 01/01/2019.

iv. **ARTICLE 3 – MAXIMUM AMOUNT AND FORM OF GRANT** of the Grant Decision shall read as follows:

3.1 The maximum amount of the grant is **EUR 74.659**.

v. **ARTICLE 4.1 – Reporting periods** of the Grant Decision shall read as follows:

The *action* is divided into the following *reporting periods*:

- Reporting period: **from month 1 to month 15**.

The new deadline for the submission of the final report is **31/05/2020**.

ARTICLE II

All the other provisions and annexes of the Grant Decision and any previous modifications, which are not changed by this decision shall remain unchanged and shall continue to apply.

ARTICLE III

The present decision shall take effect on the date it is notified to the beneficiary.

8. **Promotional Activities**: Each unit will be in charge of promotional activities at national level (i). They will also contribute actively to the promotion at European level (ii) managed by A7.
9. For the **Federal German Unit**, this will only entail cooperating with the German *Länder* Unit for the purpose of the activities mentioned above which fall within its competence.
