By signing this Amendment No. 2 to Annex B 1.0 of SGHA, both Parties have mutually agreed as follows:

### I. Subject Matter

- 1. The Parties hereby agree that in Pragraph 1 Handling charges Sub-Paragraph 1.1.1 of Section 2:
  - the service item **2.1.9 (b) (1)** shall be excluded out package price and shall be provided at extra charge without disbursement in accordance with current Prague Airport Authority official rates.

- the service item 4.4.1 (b) (on request and recharge) of Section 4 in Sub-Paragraph 1.1.1 of Paragraph 1 Handling Charges shall be entirely repealed and replaced as follows: "4.4.1 (a) included."
- The Parties hereby agree that as of the date of effectiveness of this Amendment No. 2 Amendment No. 1 to Annex B 1.0 to SGHA forfeits its validity in the full extend.
- The Parties hereby agree that the table in stated in the Sub-Paragraph 1.1.2 Charges of Paragraph 1 Handling Charges shall be entirely repealed and replaced in full as follows:

All the remaining provisions of Sub-Paragraph 1.1.2 Charges shall remain in full force and unaffected. The Charges are VAT exclusive. VAT (if any) will be levied in compliance with the Czech and EU tax law in force.

- 4 Both Parties agree to fix an additional charge under Paragraph 2. Additional charges for crew transport on apron / service item 3.6.2 (b) at ■CZK per one way ride.
- For avoidance of doubts the Parties hereby agree that charges in CZK shall be converted to EUR by exchange rate CZK/EUR published by CNB (The Czech National Bank) on the day of every invoice issuance and shall be reported by the Handling Company to the Carrier in written form on every respective invoice.

The Parties agree to add a new Paragraph 10 Trade Secret as follows:

### " Paragraph 10 Trade Secret

The Handling Company notifies the Carrier and the Carrier acknowledges that the Handling Company is a legal entity referred to in Section 2 para. 1 point n) of the Act no. 340/2015 Coll., on special conditions for the effectiveness of some contracts, publication of these contracts and register of contracts (hereinafter as "Register of

Contracts Act") and according to the Register of Contracts Act private law contracts concluded with the Handling Company are subject to the publication in the register of contracts, a public administration information system administered by the Ministry of the Interior of the Czech Republic. Notwithstanding Article 2 of the Main Agreement both Parties agree with publication of Annex B 1.0 as amended in the register of contracts with the exception of the facts that constitute business secrets.

Parties hereby jointly declare their obligation to protect a trade secret specified below appropriately:

- Annex B 1.0 of SGHA dated 16 March 2011: Carrier's identity (in the heading and signature page) and charges in Sub-Paragraph 1.1.2 "Charges"
- Addendum No. 1 to Annex B 1.0, dated 01 April 2016: Carrier's identity (in the heading, and signature page)
- Amendment No. 1 to Annex B 1.0 dated 01 September 2013: Carrier's identity (in the heading, and signature page) and charges in ARTICLE I - Paragraph 1 Handling Charges – Sub-Paragraph 1.1.2 Charges
- Amendment No. 2 to Annex B 1.0: Carrier's identification (in the heading and signature page) and charges in Paragraph I. Subject Matter Sub-Paragraph 3."

The other terms and conditions of the Annex B 1.0 of SGHA shall remain unchanged and fully applicable.
