The Contracting Parties agree that a new provision of the following wording shall be added to Article V:

6. The Issuer may issue an invoice for the Price pursuant to Article V (1) in EURO from the month following the receipt of the Customer's written request, for the purposes of invoicing the Price in EURO using the exchange rate UniCredit bank Czech Republic and Slovakia, foreign exchange-non cash mid CZK/EURO always valid on the date issuing an invoice.

Article II

No other terms or conditions of the aforementioned Contract shall be negated or changed as a result of this here stated addendum.

This Adendum shall come into force on the day it is signed by both Contracting Parties and into effect on the day it is published in the Register of Contracts within the meaning of the Act No. 340/2015 Coll., on special terms of effect of certain contracts, publishing of those contracts and on the Register of Contracts.
