



## DECLARATION ON THE SETTLEMENT OF SELECTED OBLIGATIONS OF ORDER NO. 77.19430119 FOR THE PURPOSES OF PUBLICATION IN THE REGISTER OF CONTRACTS

(“**Seller**”).

(The Buyer and the Seller are hereinafter jointly referred to as “**Parties**” and individually as “**Party**”).

### 1. INTRODUCTORY PROVISIONS

- 1.1 The Buyer is a public contracting authority and the beneficiary of a grant of the Ministry of Education, Youth and Sports of the Czech Republic within the Operational Programme Research, Development and Education. The buyer carries out a project financed by the grant specified herein in this provision („**Project**“).
- 1.2 The Seller accepted an Order No. 77.19430119 („**Order**“) on 29<sup>th</sup> March 2019, the object of which was reparation of laboratory equipment specified in the Order („**Subject of the Order**“).
- 1.3 As the Buyer is an entity required to publish contracts in the Register of Contracts (“**Register of Contracts**”) pursuant to Act No. 340/2015 Coll., on Special Conditions for the Effectiveness of Certain Contracts, the Disclosure of These Contracts and the Register of Contracts, as amended („**Act on the Register of Contracts**“), the Order was published in the Register of Contracts on 3<sup>rd</sup> April 2019.



- 1.4 The Subject of the Order was delivered (performed) to the Buyer on 29<sup>th</sup> March 2019, i.e. prior to the publication of the Order in the Register of Contracts.
- 1.5 Pursuant to Section 6 of the Act on the Register of Contracts, the Order became effective no earlier than the date of its publication in the Register of contracts, i.e. on 3<sup>rd</sup> April 2019.

## 2. THE SUBJECT MATTER OF THE DECLARATION

- 2.1 The Parties hereby expressly declare that all obligations established between the Parties in connection with the performance of the Order from the date of its acceptance, i.e. from 29<sup>th</sup> March 2019, until the date of its publication in the Register of Contracts on 3<sup>rd</sup> April, were settled in accordance with this Order.

## 3. FINAL PROVISIONS

- 3.1 This Statement is written for the purpose of publication in the Register of Contracts upon request of the Ministry of Education, Youth and Sports of the Czech Republic which provides Buyer with the grant to the Project from which is funded the Object of Purchase of the Order.
- 3.2 The Parties agree to publish the full text of this Declaration in the Register of Contracts pursuant to Act on the Register of Contracts.
- 3.3 This Declaration is executed in four (4) counterparts and each Party shall receive two (2) counterparts.
- 3.4 This Declaration shall become valid on the date of its signature of both Parties. This Declaration shall become effective on the date of its publication at the Register of Contracts.
