Section 1. Definitions

The capitalized terms used in this Annex IX shall have the meaning attributed to them in Annex I (Definition List) or in this Annex IX.

Section 2. Purpose of this Annex IX

This Annex IX sets forth the specific conditions the Service Provider should comply with against a PX with a view to allowing such PX to comply with its mandatory national laws.

Section 3. Attachment

Appendices and attachments to this Annex IX form an integral part thereof and any reference to this Annex IX shall include a reference to such appendices and attachments, and *vice versa*.

Section 4. Beneficiary

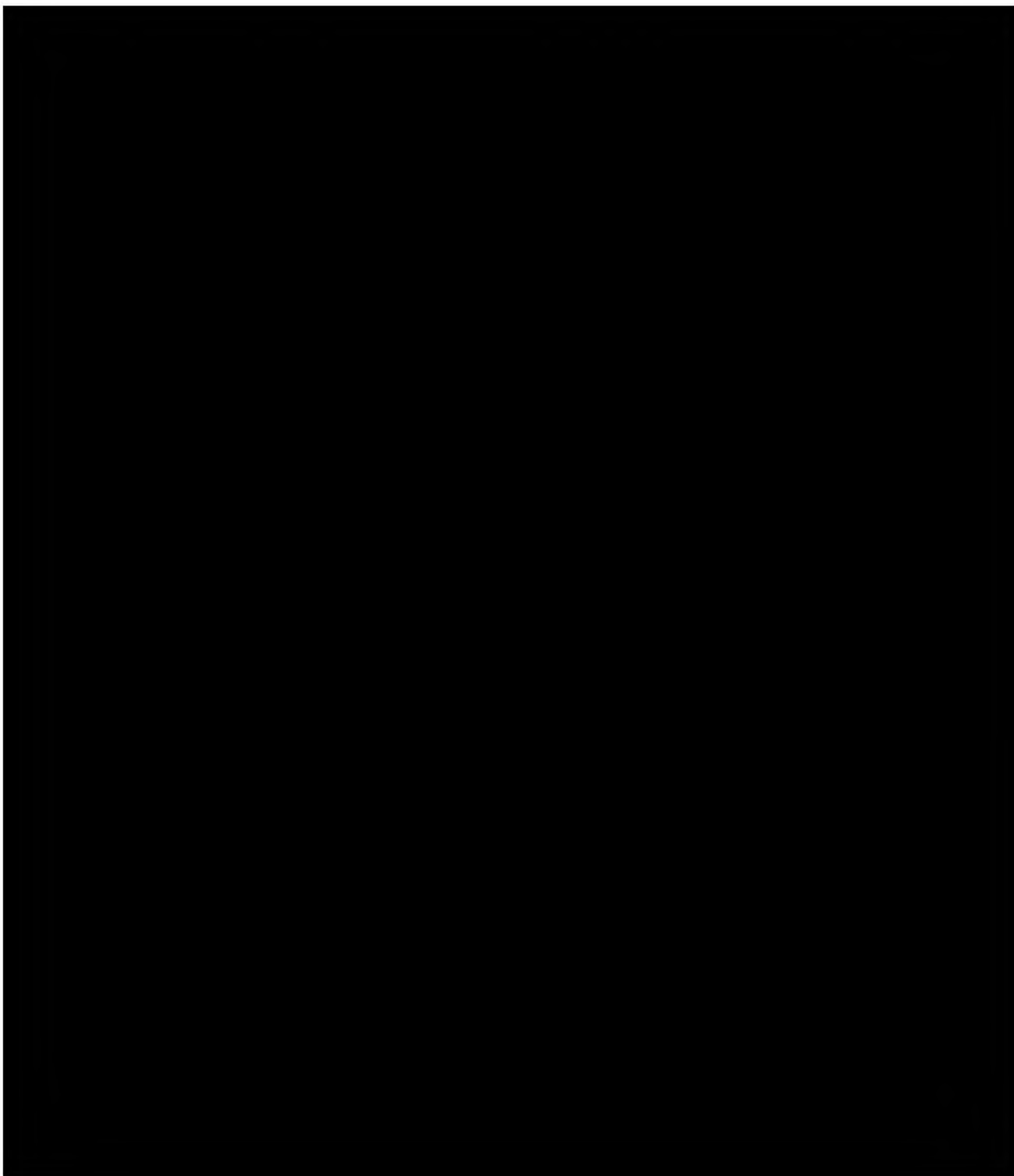
- 4.1. The provisions of this Annex IX are to the benefit only of the specific PX for whom the specific mandatory provisions set forth in an appendix to this Annex are required, meaning that only such PX can claim compliance with the provisions contained herein by the Service Provider and enforce these provisions against the Service Provider.
- 4.2. Nothing in this Annex IX shall be construed or understood as implying specific obligations of the other PXs towards the PX subject to the PX specific conditions and the other PXs shall in no event be held liable for the Service Provider’s compliance with these obligations.
- 4.3. An appendix containing the specific mandatory provisions shall be agreed between the Parties whenever mandatory national laws should be included in order for a PX to be able to adhere to the Framework Agreement.

Section 5. Governing Law

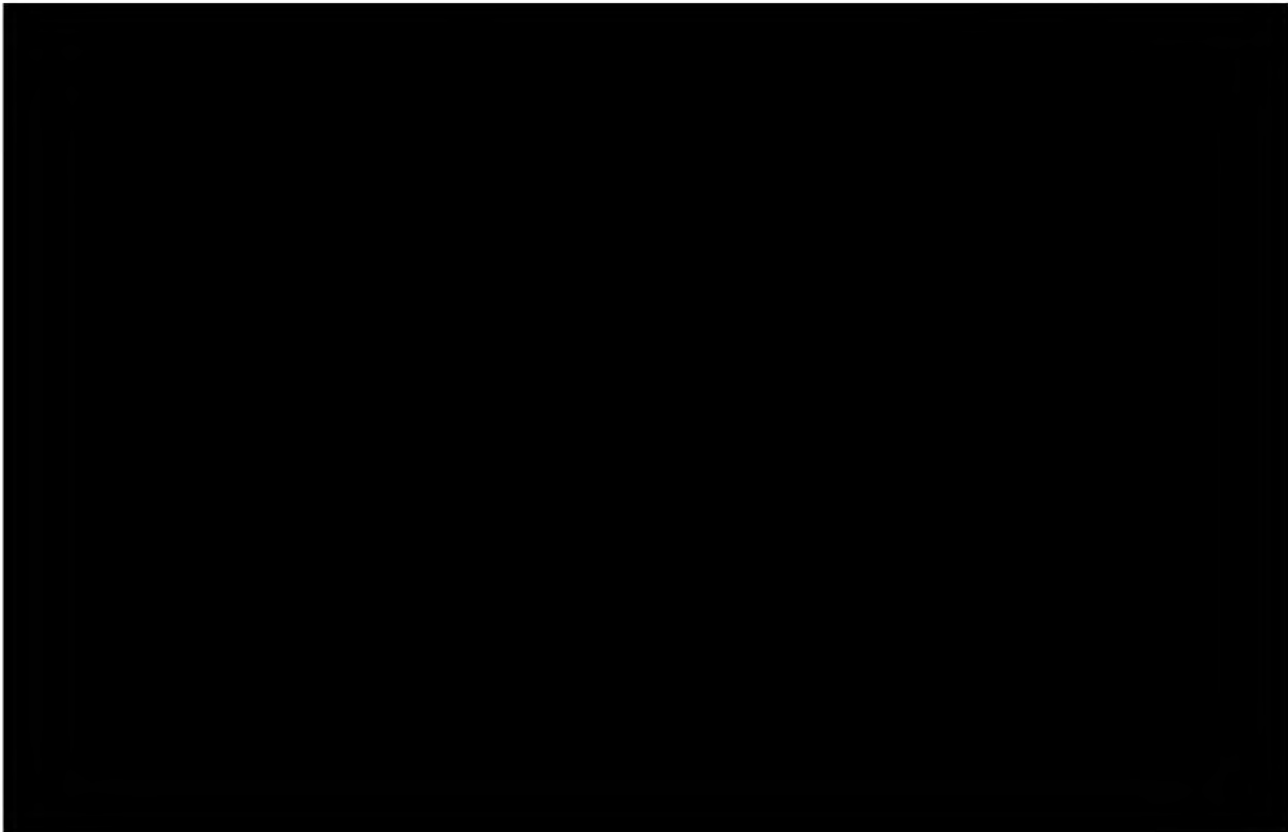
In deviation from Article 19.2 of the GTC compliance with this Annex IX and with the appendices and attachments for the specific PX for whom the specific mandatory provisions set forth in these appendices and attachments are required and that are attached hereto, and the consequences of any incompliance with this Annex IX and these appendices and attachments (such as but not limited to any specific termination possibilities) are subject to and governed by the laws mentioned in the relevant appendix, to the exclusion of the conflict of law provisions thereof.
