1 CLIENT'S ASSIGNMENT

1.1 Requirements for the scope and technical specification

The purpose of the project is to implement the jointly developed Communication Strategy of SÚRAO and support in communication activities carried out based on the Strategy.

The project will contain the following parts:

1) Support in Communication Strategy implementation by organizing 2 workshops: one for the management of SÚRAO, one for the staff *(2 groups, same content)*. The workshops will be held in Prague or elsewhere in Czech according to SÚRAO ("Client") choice by the end of 2019.

2) Support in compiling internal communication material (*e.g. presentations, articles, webpage content, mails, social media content etc.*) aimed to help in Communication Strategy implementation. This task is carried out according to needs and separate schedule agreements with SÚRAO.

3) Socioeconomic study of case of Posiva

The Consultant ("Supplier") will summarize reports the socio-economic studies it has made in 1998 - 2018. They include a.o. the following topics:

- (1) Summary of assessment methods (employment, population, municipal economy)
- (2) Comparison with the current situation (employment, population, municipal economy)
- (3) The use of assessment results, and reactions of municipalities and people.

4) Expert communications training. Supplier will organize one day's communication training for 10 experts named by SÚRAO in Prague or Helsinki or elsewhere according to SÙRAOs choice in 2020.

5) Workshops about communication topics to subcontractors The Supplier will organize two workshops with same content, consisting of Communication strategy introduction and Communication training for SÚRAO subcontractors. SÚRAO's staff responsible for the subcontractors in question can also participate. The workshops will be held in Prague or elsewhere in Czech according to SÚRAO's choice.

6) Hosting and organizing events for stakeholders in Olkiluoto, Finland. The Supplier will

- host a visit of Czech press to Olkiluoto and Eurajoki municipality

- host an excursion for the Czech mayors invited by SÚRAO to Olkiluoto and Eurajoki municipality

- host possible other visits to Olkiluoto and Eurajoki municipality

7) Participation and support in local communications at potential DGR Sites. The Supplier will participate to local communications events in a role defined together with SÚRAO. The role can be e.g. to describe the project in Finland and to answer to the questions of the participants. It will be agreed case by case, does the Supplier or SÚRAO

provide a translator. The Supplier chooses the Expert in question based on the nature of the event in question and the role agreed for the Supplier so that SÚRAO gets the "best for the purpose" -person. The PC contains one persons participation to 5 events.

8) Ad hoc support in Communications issues: small tasks as ordered by SÚRAO in written (e-mail). The Partial Contract contains 140 hours for tasks that SÚRAO will define later. If no need arises, no hours will be used nor invoiced.

The Client requires the Supplier to nominate members of the PC that will be financed from this Partial Contract.

Any changes of persons, nominated by the Client and the Supplier, are possible without a Partial Contract amendment. Client and Supplier Project Managers notify in writing the change to other Project Manager.
