Art.1. Subject of the contract

The subject of the contract is the provision of 100 licenses of IENC viewers in information mode according to the IECDIS version 2.4 defined by Commission Implementing Regulation (EU) 2018/1973 of 7 December 2018 amending Implementing Regulation (EU) No 909/2013 on the technical specifications for the electronic chart display and information system for inland navigation (Inland ECDIS) referred to in Directive 2005/44/EC of the European Parliament and of the Council, with following functions and parameters:
