### 1. Subject matter of the contract

The subject of the contract is the regulation of personnel consultations by the contractor as well as regulating the transfer of staff to the client and his partners.

### 2. Employment order

### 5. Success fee

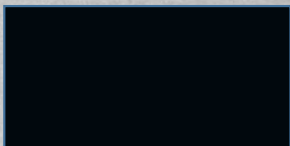
Both parties agreed on a commission for each job individually, according to attachment. The commission is paid on the worker starts to work in the Czech Republic.

7. Other agreements

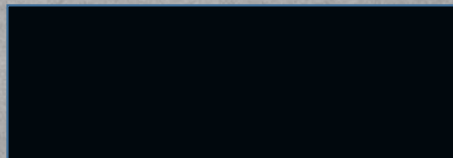
Changes to this contract must be made in writing. The Contracting Parties undertake to do as closely as possible to what was originally intended.
