ARTICLE 1: SUBJECT OF THE CONTRACT

The Subcontractor undertakes to perform activities according to baseline work for the following Work Packages:

• WP3220 as described in the Work Package Descriptions in HECS WBS+WPD 20180906 Excel (enclosed), under the main contract: Signed ESA contract No. 4000125580/18/NL/GLC and references therein.

The complete work shall be delivered at least one week prior to final delivery to IRF and progress of the work shall be reported and shared with SSC regularly when performing the task.

ARTICLE 2: PRICE AND PAYMENTS

The total price of this subcontract amounts to:

€ 33 500

(thirty-five thousand Euro)

The price of this subcontract is stated to be firm fixed price.

The price does not include any taxes and duties in the Member States of the European Space Agency.

Payment for each MS will be paid to the Subcontractor after the Contractor has been provided with the particular subcontracts corresponding to the particular MS and SSC will receive the final customer's (ESA's) acceptance and approval of the execution of a particular MS. The moment of acceptance and approval of the execution of the particular MS by the final customer is also considered the date of receipt of the contract without obvious defects by SSC and the moment of date of taxable supply. The contracting parties agree that due to the fact that all activity on the contract is subject to final approval by submitter ESA, the SSC shall promptly notify the subcontractor in writing without delay of receipt of the approval and receipt of the contract (or particular MS) from the final customer (ESA) including stating the date of such confirmation by ESA and the subcontractor shall on the basis of this information within 15 days after receiving such information issue an invoice – tax document in the amount of 100% corresponding to the particular MS + VAT in the legal amount, the invoice will be due within 90 days. At the same time, the contracting parties agreed that SSC shall within 15 days after receipt of particular invoice pay the amount corresponding to 50% of the principal (sum) according to the particular MS which is due according to the particular invoice.
