



Donation Agreement

This agreement (the "Agreement") is made by and between

IKEA Supply AG, with registered address Grüssenweg 15, CH 4133 Pratteln, Switzerland ("IKEA"); and

and VAT No

(the "Receiving Party")

IKEA and the Receiving Party have agreed as follows.

1. IKEA hereby transfers the ownership and title of the IKEA articles listed in Appendix 1 Report of Donation (the "Donated Articles") to the Receiving Party with the limitations stated in this Agreement. No compensation shall be paid by the Receiving Party to IKEA. The Donation Approval Number of the Appendix is:

2. Any transport of the Donated Articles shall be paid by the Receiving Party, unless otherwise agreed in writing between the parties.
3. The Receiving Party may only use the Donated Articles according to the purposes that are described in the statutes of the Receiving Party, and/or for contribution to a social or environmental purpose.
4. IKEA reserves the right to monitor and review the Receiving Party's handling of the Donated Articles by means of unannounced visits and otherwise.
5. The Receiving Party may not, at any time, sell the Donated Articles to any third party.
6. The Receiving Party may not at any time return the Donated Articles to IKEA, if not otherwise agreed between the parties in writing.



7. The Receiving Party, any of its employees, volunteers or the ultimate receivers of the Donated Articles are solely responsible for the Donated Articles. IKEA shall not be held liable or responsible whatsoever for the Donated Articles after this date. The Receiving Party shall indemnify and hold IKEA harmless for any damage, claim, loss or expense arising from the Donated Articles as such or the use of the Donated Articles. Further, IKEA shall not be held responsible for any damage to the Donated Articles, the incompleteness thereof or accidents resulting from the handling or use of the Donated Articles.
8. At the receipt of 10 or more articles the Receiving Party shall present a brief report which clearly states what the Donated Articles were ultimately used for and the address at which they are set-up. This report must be documented with necessary photographs and must be signed by the Receiving Party. The report shall be submitted to IKEA within 45 calendar days from this date.
9. If the conditions under this Agreement are not complied with by the Receiving Party, IKEA reserves the right to demand the return of the Donated Articles or an amount paid by the Receiving Party corresponding to the value of the Donated Articles, such value to be decided by IKEA at its own discretion.
10. The Receiving Party is responsible for assembly of the Donated Articles.
11. This Agreement shall be governed by the laws of Switzerland.
