concluded this Amendment No. 1 to the Publisher's Licence Agreement – undersigned 21st of October, effective since 23rd of October 2019 (hereinafter referred to as "amendment" and „agreement“) in accordance with the section VIII. article 2 of the agreement

I. Change of the agreement

1. Contractual parties agreed, that the section IV. article 1 will be:

“UP will pay to the licensee as the part of the costs of publication and distribution of the work (as the reward for the publication, distribution and other services) amount of 2500 EUR excl. VAT, in accordance with the invoice issued by the licensee (since the moment, when the value

of the services provided by the licensee is equal to the abovementioned amount - 2500 EUR excl. VAT) with fifteen-day maturity period starting on the day of its delivery to UP on the e-mail address [redacted] cz or on the address Faculty of Arts of Palacký University Olomouc, Křížkovského 511/10, 771 47 Olomouc by the mail. The VAT is not included in this amount and won't be added to it due to the fact that the Publisher is not the VAT payer."

II. Final provisions

1. Other sections and articles of the agreement remain unaffected by this amendment.
2. This amendment is executed in English version in four identical copies with the force of original, two copies for each party.
3. The parties hereto acknowledge the fact that this amendment is subject to obligatory publication under the Czech Act No. 340/2015 Coll. On Special Conditions of Effect of certain Contracts, Publication of these Contracts and on the Register of Contract (Act on the Register of Contracts). The parties take note that this amendment enters into effect at the moment of its publication in the register of contracts. UP, who shall ensure publication of the amendment in the register of contracts, shall inform the licensee of its publication forthwith thereafter using the e-mail [redacted]
