

I. Purpose of the Contract

- 1) Parties have concluded the Cooperation Agreement on 27. 9. 2017 to define mutual rights and obligations between the Parties in relation to the Contractor's performance for the University concerning the Contractor's participation in Steering Committee within EMPIRE registry (hereinafter referred to as the Agreement).

II. Subject of the Amendment

- 1) The Parties have concluded to prolong their cooperation under the conditions of the Agreement and thus the Parties hereby replacing the wording of the article III. par. 1 of the Agreement by the following wording:

"This contract is concluded for a definite period of time - from the moment of signing of this Contract until the end of the project duration, but no later than 30. 9. 2022, whichever comes first."


III. Final provisions

- 1) Contractual arrangements of the Agreement not regulated by this Amendment remain unchanged.
- 2) Parties acknowledge that the University is an obligated subject under the Act no. 340/2015 Coll. of the Czech Republic, on special conditions for the effectiveness of some contracts, the disclosure of these contracts and the Registry of contracts (Act on the Registry of contracts). Parties declare that they agree that the Amendment will be published by the University in the Register of contracts under the conditions of the Act on the Register of contracts.
- 3) Parties declare that the confidential parts of the Amendment will not be published in the Register of contracts. If Parties will not disclose the Amendment or its parts in the Register of contracts under the Act on the Register of contracts they are pursuing the mutual protection of legitimate interests.
- 4) This Amendment is valid on the day of its signature by both Parties and effective on the day of its publication in the Register of contracts.
- 5) This Amendment is executed in two counterparts, each Party shall receive one copy.


