

AMENDMENT NO. 1 TO THE DONATION AGREEMENT CONCLUDED ON 26TH MAY 2017, NUMBER OF AGREEMENT: 025776/2017/00**NUMBER OF AMENDMENT: 1**

On 26th May 2017 the following parties entered into the Donation Agreement (hereinafter the "Agreement"):

hereinafter referred to as the "**Donee**" or the "**Beneficiary**";

(the Rigaku and the CEITEC BUT are hereinafter referred jointly to as the "**Parties**" and each individually as a "Party");

IT HAS BEEN AGREED AS FOLLOWS:

1. **SUBJECT OF DONATION**

The Donor undertakes to donate a financial donation in the amount of 36 000 USD per year to cover the cost of the annual study visit of a student of the Donee-to the Donor for a combined of 6 months per year for a period of three years - 2017, 2018 and 2019. The Donee accepts the donation mentioned herein, which is intended for covering the costs of the study visit of the student.

2. **CHANGES OF THE AGREEMENT**

2.1. The Donor and the Donee have agreed in the case the financial donation for years 2017, 2018, 2019 has not been taken in full, the remaining amount of the donation can be drawn in year 2020. The amount will be used as follows:
