Loan Agreement No. 5/2020

Concerning the temporary use of the following items:

For the purpose of: **Exhibition “In the centre of Bohemian Crown. Gothic and Early Renaissance Art in Eastern Bohemia 1250-1550”, held from 6th February 2020 till 28th June 2020**

The items are being loaned: free of charge

Starting from: not earlier than 13th January 2020, respectively from the date the item is handed over to the transport company. The exact date will be specified on the “handover protocole” which is the part of the agreement.

Until no later than: 17th July 2020, respectively till the date the item is handed over to the owner. The exact date will be specified on the “handover protocole” which is the part of the agreement.

The Borrower undertakes to fulfil the following conditions:

1. No changes or alterations of the items shall be made.
2. The items shall be placed in an environment corresponding to their importance and condition.
3. Adequate security, air-conditioning, and any other measures shall be taken in order to ensure that the items do not suffer harm and are not lost. ~~The conditions must be kept as follows: Intensity of the light should not exceed 50 lux, rel. humidity 50% +/- 5%, max. temperature 18 °C.~~
4. The item will be transported by the specialized art transport company.
5. The item will be on display from 6th February till 28th June. ~~During the exhibition period the folios of the manuscript will be changed in this following order:~~

~~6th February — 9th March 2020: — fol. 1r: A(doramus)~~

~~9th March — 6th April 2020: — fol. 12v: S(piritus sanctae deus)~~

~~6th April — 4th May 2020: — fol. 14r: O (Maria mirabiliter)~~

~~4th May — 1st June 2020: — fol. 17r: O (virgo benedieta)~~

~~1st June — 28th June 2020: — fol. 33v: N(onne tibi corde)~~

~~The page changing will be made under the supervision of the curator and restorer of the East Bohemian Museum in Hradec Králové.~~

6. The items shall be returned to the Lender at the Borrower’s expense by the set date and in the manner agreed in advance, and shall be intact.
7. The items shall not be used for any purpose other than the purpose agreed and during the term of the loan, they shall not be loaned to another user.
8. The items shall not be photographed, filmed, copied, or subjected to any other handling without the Lender’s consent.
9. In justified cases, professional supervision shall be arranged for the duration of the loan at the Borrower’s expense.
10. The Borrower undertakes to pay any damage for which it is demonstrably responsible.
11. If it is required by a material interest, the Borrower shall insure the items at the Lender’s request.
12. For serious reasons, the items may be returned to the Lender at its request prior to the set date.
13. While on display, the items shall be identified as coming from the Lender’s collection.
14. Any request for an extension of the Loan Agreement shall be submitted to the Lender no later than 14 days before the date originally agreed for the return of the items by the Borrower.

15. This Agreement has been executed in three original counterparts, one for the Lender and two for the Borrower.
16. A hand-over protocol which will be signed at the time of the hand-over of the items constitutes a part of the Agreement.
17. Detailed photographic documentation of the physical condition of the items on loan constitutes a part of the Agreement.
18. The Borrower is subject to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) and to the applicable Act No. 101/2000 Coll., on personal data protection. Personal data is only provided for the duration of the purpose and subsequently, it will be handled in accordance with the Discarding Rules of the East-Bohemian Museum in Hradec Králové.
