

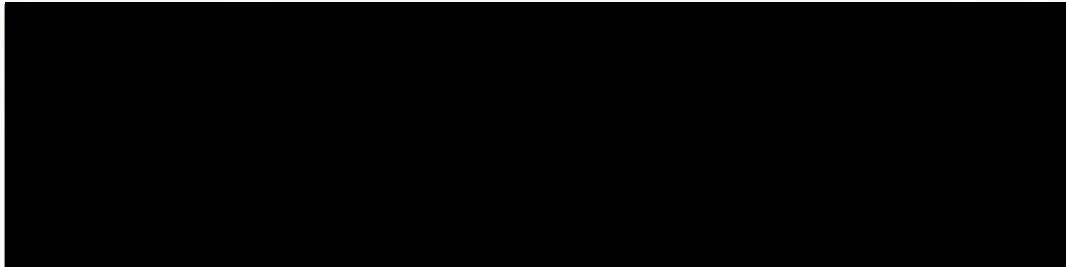

**Re: Programme Licence Agreement between Zodiak Rights Limited ("ZR") and Ceska Televize (the "Licensee") dated 29 November 2013 (the "Agreement") (Zodiak Ref: RKD-14266) – Amendment No.1**

ZR refers to the above Agreement. All capitalised terms in this Amendment No.1 shall have the same meaning as in the Agreement unless otherwise specified. In the case of any discrepancy between the Agreement and this letter, the provisions of this letter shall prevail. The parties hereby agree to amend the Agreement as follows:

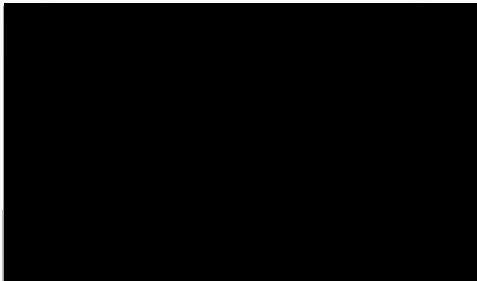


With regards to the fact that the Agreement is subject to an obligation to make the contents of the Agreement public based on the Act on Registration of Agreements (Act No. 340/2015 of the Czech Collection of Laws – hereinafter as the "**Act on Registration of Agreements**") due to the execution of this Amendment No.1, contracting parties upon mutual agreement highlighted in yellow information in the copy of the Agreement and in this Amendment No.1 that shall be redacted (blackened out) pursuant to the Act on Registration of Agreements. To avoid any doubts, it is hereby stipulated that the following parts of the Agreement shall be redacted: Schedule A – sections: A.3., A.4., A.5., A.6., A.7., A.8., A.9., A.10., A.11., A.13., A.16., A.17. (with the exception of total material charge), A.18 (with the exception of last two paragraphs), A 25 – information on the amount of compensation of costs only), content of Schedule B, personal data, initials and signatures. Information not highlighted in yellow shall not be subject to the duty of confidentiality. Only the Licensee shall be entitled to make the Agreement and this Amendment No.1 public pursuant to the Act on Registration of Agreements within the time period of 80 days commencing upon its execution. Provided that the Licensee does not make the Agreement and this Amendment No.1 public within this time period, either party shall be authorized to make the Agreement and this Amendment No. 1 public pursuant to the Act on Registration of Agreements.

All other terms and conditions of the Agreement shall remain in full force and effect.

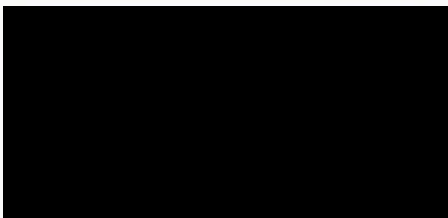
