- (1) Article 2.2 is replaced by the following article:
- "2.2 The action shall run from 13/09/2016 ("the starting date") until 30/06/2020 ("the completion date")".
- (2) Article 4.1.1 "Reporting periods" is replaced by the following article:

"4.1.1 Reporting periods

The action is divided into the following reporting periods:

- Reporting period 1 from the starting date of the action to 31 December 2017;
- Reporting period 2 from 1 January 2018 to 31 December 2018;
- Reporting period 3 from 1 January 2019 to 31 December 2019;
- Last reporting period from 1 January 2020 to the completion date of the action."

"ANNEX I

DESCRIPTION OF THE ACTION

ARTICLE I.1 – IMPLEMENTATION OF THE TEN-T NETWORK

The action contributes to the implementation of the:

- the core network
 - Horizontal priority: Telematic applications systems for rail (ERTMS).
 - Corridor(s): Baltic Adriatic
 - Pre-identified section(s) on the core network corridor(s):
 - Katowice Ostrava Brno Wien and Katowice Žilina Bratislava Wien

ARTICLE 1.2 - LOCATION OF THE ACTION

- 1.2.1 Member State(s): Czech Republic.
- I.2.2 Region(s) (using the NUTS2 nomenclature): Jihovýchod (CZ06), Moravskoslezsko (CZ08), Strední Morava (CZ07).
- I.2.3 Third country(ies): not applicable.

ARTICLE I.3 - SCOPE AND OBJECTIVES OF THE ACTION

The Action covers the trackside deployment of ETCS Level 2, Baseline 3 on a 204 km double-track line Petrovice u Karviné – Břeclav-Hrušky. This line forms the entire Czech part of the Baltic – Adriatic Core Network Corridor. In addition the Action includes the adaptation of the GSM-R on some ETCS entry points from branch lines covered or planned to be covered with GSM-R signal.

Following the completion of the Action 204 km of conventional railway line between Petrovice u Karviné (PL border) and Břeclav-Hrušky will be equipped with ETCS Level 2, Baseline 3 and authorised for commercial service. The authorisation procedure will be in line with the applicable interoperability legislation.

The action is a part of the Czech National ERTMS Deployment Plan aiming at the deployment of ERTMS on all Czech transit railway corridors.

Completion of the Action will contribute to the Czech National ERTMS Deployment Plan ensuring the interoperability of the Czech railways Core Network and consequently it will improve the cross-border operation with AT, PL and SK, once they all have implemented the ETCS on the cross-border sections with Czech Republic.

1.4.2 Activities description

<u>Activity 1</u>: ETCS deployment on the line Petrovice u Karviné – Ostrava – Přerov – Břeclav

The activity covers the deployment of ETCS Level 2, Baseline 3 including GSM-R adaptation on a 204 km long section between Petrovice u Karviné (PL border) and Břeclav-Hrušky, which is part of the Baltic - Adriatic Core Network Corridor.

The GSM-R component of the activity encompasses the construction of 3 new Base Transceiver Stations (BTS) at the railway stations Hranice na Moravě - město, Sedlnice and Kunovice and modification of further 2 BTS in the station Bohumín and Moravský Písek. The Adaptation of the GSM-R is necessary in order to ensure smooth entry into ETCS from branch lines that are or will be equipped with GSM-R.

Deliverables of the activity shall cover the authorisation procedure documents. Reference of the following documents to the above mentioned section must be clearly demonstrated:

- 1. EC declaration of conformity for each interoperability constituent relevant for ERTMS issued by the supplier or the supplier's authorised representative established within the Union, including all the relevant certificates of conformity from a Notified Body. The EC declaration of conformity shall be fully in line with annex IV of the Interoperability Directive;
- 2. Information regarding tests results (test report including the operational scenarios) in line with the applicable TSI CCS, performed with on-board unit(s) provided by at least one different supplier to the one in charge of the line equipment. The on-board unit(s) used for the tests shall be compliant with the applicable TSI CCS;
- 3. EC declaration of verification of the CCS subsystem issued by the applicant for each CCS subsystem installed including all the relevant EC certificates of verification of subsystem from a Notified Body and the safety assessment report following TSI CCS; the EC declaration of verification shall be fully in line with annex V of the Interoperability Directive;
- 4. Copy of an application for a National Safety Authority authorisation placing the CCS trackside subsystem in service or the NSA authorisation in case available by the time the final payment claim is due.




