<u>Product Terms</u> Scientific American and Scientific American Plus

1. Term and Access Rights

- 1.1 The Term shall begin on 1st January 2020 (the "Commencement Date") and shall end on 31st December 2020.
- 1.2 <u>Continuing Access</u>: During the term, for Scientific American, as a single title product or as a component part of Scientific American Plus, Licensee shall have access to the Content first published during the Term. After the Term, Licensee shall have Continuing Access to the Content first published during the Term, subject to all the terms and conditions of this License Agreement. For clarity, there shall be no Continuing Access to Scientific American eBooks and Scientific American Collections.

1.3 Backfile Access During the Term:

- 1.3.1 For Scientific American as a single title product: During the Term only, Licensee will be granted access to Scientific American Content published beginning four years prior to the Commencement Date.
- 1.3.2 For Scientific American Plus: During the Term only, Licensee will be granted access to all the Scientific American Plus Content (as defined below in Section 2) published a) beginning in 2012 or if later (b) the first date of publication.
- 1.4 For any Licensee that currently has access to Scientific American under a separate agreement, the Licensee's access to Scientific American shall be governed by whichever Product Terms provide the Licensee greater Continuing Access and/or Backfile Access to Scientific American.
