SUBJECT-MATTER AND PURPOSE OF THE CONTRACT

1. The Donor makes a donation of 30.000 pieces of personal protective equipment with following specification **Medical Masks** to the Donee as its own contribution to protection of public health in Czech Republic in connection with COVID19 outbreak ("Donation"). The Donor hereby represents that the value of the Donation (exclusive of VAT) is of CZK **1.800.000 CZK** (60 CZK per mask). The Donee accepts the Donation and undertakes to use it only for the purposes set out as per purpose expressed under this Article.
2. The Donor undertakes to deliver the Donation to the Donee within **3** days since conclusion of this Contract to the following destination: site of the Donee (Budínova 67/2, Praha 8 – Libeň), whereas the particular place of delivery will be agreed upon by the Parties.
3. The Donee acquires the ownership of the Donation on the date of hand-over.

II.

FINAL PROVISIONS

1. This Contract has been made in three counterparts of which the Donee will receive one counterpart and the Donor two counterparts.
2. This Contract comes into force on the date of the signing thereof by the Parties, and it comes into effect on the day of its publication in the Register of Contracts according to Act No. 340/2015 Sb., on the Register of Contracts, as amended. The Donee will publish this Contract in its entirety in the Register of Contracts according to the above Act on the Register of Contracts.
3. Any and all alterations and amendments hereof may only be made in the form of written amendments approved and signed by both Parties.
4. In respect of the issues not expressly regulated by this Contract, the rights and obligations of the Parties are governed by the applicable provisions of Act No. 89/2012 of Coll., Civil Code, as amended.
5. Both Parties confirm that they have carefully read the Contract, that they understand its content, that the conclusion of the Contract in this wording is an expression of their true, free and serious will and that the Contract is not entered into under markedly unfavourable conditions, in witness whereof they affix the signatures of their authorised representatives.
