

AMENDMENT NO. 1
TO SECONDMENT AGREEMENT between ECRIN-ERIC AND MASARYKOVA
UNIVERZITA for Ms [REDACTED]

This first amendment to the "Secondment Agreement" is made by and between:

Masarykova univerzita, Reg. No. 00216224, a public university incorporated under the laws of Czech Republic, having its registered office in Žerotínovo náměstí 9, 601 77, Brno, Czech Republic

Represented by doc. MUDr. Martin Repko, Ph.D. The Vice Dean for International Affairs and International Study Programmes of the Faculty of Medicine, located in Kamenice 5, 602 00, Brno. (the "Institution")

Hereinafter referred to as "**the Masarykova univerzita**"

AND

European Clinical Research Infrastructure Network (ECRIN-ERIC), registered under SIRET n°801 933 235 00021, established in 5-7 rue Watt, 75013 Paris, France, represented by Prof. Dr. Jacques Demotes, Director General of ECRIN ERIC

Hereinafter referred to as "**ECRIN**"

Hereinafter individually or collectively referred to as the "Party" or the "Parties"

WHEREAS ECRIN and Masarykova univerzita entered into a Secondment Agreement (Secondment agreement_ECRIN-ERIC_Masarykova univerzita_V2_2 Eucos_26 04 2018) (the "Secondment Agreement") as of 29/05/2018.

WHEREAS the Masarykova univerzita has informed ECRIN that Ms [REDACTED] (the **Seconded**) will go on long-term planned leave from **1st October 2019** until **31st December 2020** (hereinafter referred to as "leave").

WHEREAS the Masarykova univerzita has informed ECRIN that Ms [REDACTED] will replace [REDACTED] during her leave.

WHEREAS ECRIN has agreed to replace Ms [REDACTED] during her leave with Ms [REDACTED]. The latter will be seconded to ECRIN in order to act as rely to the national clinical research network and hub for various ECRIN-ERIC activities as described in the Job description attached to the present Amendment 1. (see Appendix 2)

Consequently, the parties agree to modify the terms and conditions of the aforementioned Secondment Agreement as follows:

1. The **Schedule 1: Acknowledgement by the Secondees** is hereby amended by inserting the name of Ms [REDACTED] followed by the mention "**replacement of Ms [REDACTED]**" as described in Attachment1. For the avoidance of doubt, Ms [REDACTED] shall read and sign the Acknowledgement form (see Appendix 1) as part the Secondment agreement.

2. The **Schedule 2 : Job description** is hereby amended by inserting the Job description for Ms [REDACTED].

3. For the avoidance of any doubt, Masarykova univerzita as employer of Ms [REDACTED] shall ensure that her statutory employment rights stay protected during and after her leave.

4. Except as expressly set forth in this Amendment, the terms and conditions of the Secondment Agreement remain in full force and effect.

5. The Amendment shall enter into force on the day of its publication in the Czech registry of public contracts (Effective date) and shall remain in effect until the end of the period of leave of Ms [REDACTED].
