I. Předmět smlouvy

Předmětem koupě dle této smlouvy jsou MASKY EASYBREATH značky SUBEA určené na šnorchlování, (dále jen „věc“). Konkrétní počet prodaných věcí bude záviset na dostupnosti na jednotlivých prodejnách a skladu prodávajícího a bude vždy potvrzen podpisem předávajícího protokolu, jehož vzor je přiložen jako příloha č. 1 k této smlouvě. Kupující se zavazuje, v případě, že dojde k naskladnění, převzít min. 900 ks. věci na prodejně prodávajícího Decathlon Chodov, a to s ohledem na mimořádnou objednávku ze skladu mimo Českou republiku.

II. Cena a způsob placení

Cena za 1ks věci činí **400,- Kč vč. DPH**. Kupující zaplatí na základě řádně vystaveného daňového dokladu do třiceti dnů od doručení daňového dokladu částku, která se rovná celkové ceně koupených věcí (tedy 400,- Kč vč. DPH za každý převzatý kus věci) na účet prodávajícího: UniCredit Bank a.s., číslo účtu **2105615190/2700**. Cena se považuje za uhrazenou dnem připsání částky na účet prodávajícího. Daňový doklad bude vystaven nejdříve v den převzetí věci kupujícím.

III. Termín a místo předání

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Decasport s.r.o. (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
