Through the friendly negotiation of both parties, we make the following supplements and changes about the contract in March 16, 2020, No: 20200315-1:

1. Party A and party B have signed the contract for the purchase of disposable medical masks. The total price is 4,980,000 dollars and the count is 1,500,000 pieces. This product is a medical protective mask that produced by Henan Scorsese Technology Development Co., LTD.
2. 750,000 pieces of the 1,500,000 disposable medical masks in contract have arrived in Czech Republic in March 2020.
3. Due to the strict regulation by the State Foreign Exchange Administration of China, the process of converting RMB into US dollars and sending it to the Czech Republic requires a lot of approvals and takes too long, so the contract signed between the two parties is completed through the exchange of goods. After friendly negotiation between the two parties, the remaining 750,000 disposable medical masks of contract were replaced with Powecom KN95 masks made by Guangzhou Powecom Safety Goods Manufacturing Co.,Ltd, totaling 1,346,000 masks, and unit

price of each is 1.85 dollars, totaling 2,490,000 dollars. The supplier is Shanghai Maitai Medical Instruments Co., Ltd.

4. Party B promises that by May 1, 2020, Party B will deliver 1,346,000 Powecom KN95 masks produced by Guangzhou Powecom Safety Goods Manufacturing Co.,Ltd to the China's warehouse required by Party A and deliver them to the designated warehouse of Party A.

5. Party B promises that the Powecom brand KN95 mask delivered to party A by Guangzhou Powecom Safety Goods Manufacturing Co.,Ltd must be genuine. When the goods are delivered, the delivery note stamped with the official seal of Guangzhou Powecom Safety Goods Manufacturing Co.,Ltd will be attached. If the goods have quality problems, Party B will bear all legal responsibilities and losses.

6. This is the supplementary clause 2, which shall come into force upon the signature and seal of Party A and Party B. in the meanwhile, the supplementary clause 1 shall be void and null.
