

## Deed of Gift

concluded under § 2055 et seq. of Act No. 89/2012 Coll., Civil Code, as amended, and in accordance with § 12 Act No. 219/2000 Coll. About Property of the Czech Republic and its Acting in Legal Relationships (“Contract”)

between

### I.

#### Contract Purpose

1. Government of the Czech Republic declared by its Resolution No. 194 dated 12<sup>th</sup> of March 2020 in accordance with Article Nos. 5 and 6 of the Constitutional Law No. 110/1998 Coll., About Security of the Czech Republic, for the territory of the Czech Republic, on the ground of health threat in connection with spread of coronavirus referred to as SARS CoV-2, on the territory of the Czech Republic emergency conditions.

2. In connection with declaration of emergency conditions, solution to incurred crisis situation and provision of necessary medical material the Contracting parties agreed that the Donator transfers to the Donee the following specified moving goods without charge – protective equipment. Free transfer is made in public interest to satisfy the Donee’s needs and needs of the citizens.

**II.**  
**Object of gift**

1. Based on this Contract the Donator transfers to the Donee without charge the rights to the following movable goods:

100,000 (in wording one hundred thousand) pieces of disposable medical mask

**("Gift")**

and the Donee accepts receipt of the Gift to its ownership.

2. The Donee agrees that the Gift is purposely intended for use of the Government of the Czech Republic and it commits itself to use the gift exclusively in the public interest for the purpose of the COVID-19 mitigation in the Czech Republic. In accordance with the Czech Republic Government Resolution No. 286 dated 23<sup>rd</sup> of March 2020 the Donee commits itself to distribute the Gift to those in need without undue delay after the Gift is delivered to the Czech Republic.

3. Contracting parties mutually declare that the Gift is not considered as material primarily intended for use of healthcare workers.

4. Contracting parties mutually declare that neither the Donator nor the Donee are responsible for incorrect wearing of protective equipment by final user or for possible infection of persons.

**III.**  
**Method and time of fulfillment**

The Donator will provide the Gift to the Donee after this Contract is concluded through Warehouse: Warehouse address No.88 &168 Tianrui Road, Qingpu District , Shanghai, Warehouse manager: Hu Changsong, tel: +86 181 1850 8372, agent at international airport Shanghai, China without due delay.

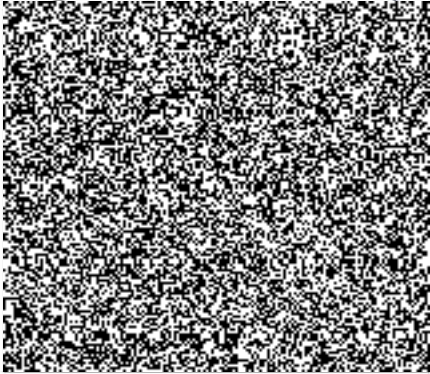
**IV.**  
**Final Provisions**

1. This Contract is governed by the Czech Republic Legal Order, particularly by relevant provisions of Act No. 89/2012 Coll., Civil Code.

2. Contracting parties hereby expressly declare that they read the Contract prior to its execution, the Contract is made based on mutual negotiation in accordance with their free will, they agree with the content of the Contract and to prove this, they attach bellow their signatures.

3. This Contract is made in two copies, each copy has the validity of the original. Each contracting party will receive one copy of the Contract.

4. This Contract is valid and effective on the day of signature by both Contracting parties.
