- (1) On 12 June 2018 the PXs have entered into the All NEMOs Intraday Operational Agreement (hereafter the "XBID Cooperation Agreement") setting forth the terms and conditions in respect of the co-operation for the implementation of a single European intraday price coupling of power regions (hereafter the "XBID Cooperation");
- (2) In the context of the XBID Cooperation the Initial PXs assigned to DBAG the provision of certain ICT services in the context of the XBID Cooperation (hereafter the "Services") subject to the terms and conditions of a services agreement entered into on 1 March 2015 by the Initial PXs and DBAG, including all exhibits thereto and including any attachments to these exhibits (hereafter the "XBID-MSA");
- TGE acceded to the XBID-MSA on 12 December 2018 and received services from DBAG as of 1 September 2018;
- (4) BSP, CROPEX, HUPX, IBEX, OPCOM and OTE acceded to the XBID-MSA on 1 July 2019 and received services from DBAG as of that date;
- (5) New PX acceded on [DATE] to the XBID Cooperation Agreement; and
