Both parties agree to following items based on friendly negotiation:

1. This agreement is Amendment 1 to the Incubation contract signed by Parties on August 8th, 2019 (valid from August 14th, 2019).
2. Incubatee won E-GNSS accelerator prize in the Galileo Masters competition (organized by AZO - Anwendungszentrum GmbH), thus becoming eligible for 61 428 EUR of additional funding. All costs will be administered by the Provider on behalf of the Incubatee. The Incubatee shall inform representative of the Provider of any desired purchases (items or services) within reasonable time and will provide all necessary information needed to execute purchase order.
3. Incubatee shall present revised incubation and budget plan for ESA BIC Prague within 2 weeks from the signature, in order to secure compatibility of the two funding schemes.
4. Incubatee shall adhere to the rules of conduct established by AZO - Anwendungszentrum GmbH for the E-GNSS accelerator, including eligible costs and deadlines. Every month shall the Provider receive brief mission report and plan of activities and desired purchases for following month. The Provider reserves the right to advise the Incubatee on its desired purchases and to adjust their structure to accommodate relevant legal requirements.
4. Except for the above added terms, other terms of the ESA BIC incubation stay in place.
5. This Amendment 1 shall enter into force upon signature by both parties.
