ECTS Grade	Percentage of Students Approved

In order to establish the course units grades for each group of the European Credit Transfer and Accumulation System (ECTS) grading scale, the distribution of students with passes in the previous three academic years and/or in a total of at least a hundred students is taken into consideration. When a cohort of this scale is impossible, the ECTS grading scale is replaced by the use of an institutional conversion table based on all course units grades of all ISAG — European Business School's Degree Courses from the previous three academic years.
