1. Purpose of the Commercial Agreement

The purpose of this Commercial Agreement is to define and assign the training courses required by the Customer and provided by AHD.

2. Training Courses

The Commercial Agreement covers the purchase of "Wet" lease training in 2020 on the EC135 Simulator.

The Customer agrees to purchase the following simulator training course:

2.1 Wet Lease

Emergency Refresher VFR Training including:

- 1 day theoretical VFR Refresher training
- 1 day theoretical System Refresher training
- 4 slots per pilot

For 18 pilots and 17 Flight Engineers

2.2 Location

All training courses will be performed at the Training Academy in Donauwörth Dr.Ludwig-Bölkow-Straße 4,Germany.

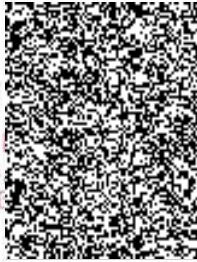
