1. The Prague Zoo puts at the disposal of the Recipient the following animals for breeding and for associated display purposes:

(Hereinafter referred to as the Animals)

2. The Prague Zoo confirms that it is the owner of the Animals.
3. The Animals will belong to the Recipient after delivery.
4. The Prague Zoo provides no warranty as to the health of the Animals. The Prague Zoo assures that it is aware of the Animal's having not any diseases or contagious diseases. The Animals will be delivered in a good state of health, without any clinical symptoms of disease.
5. The Prague Zoo arranges CITES export permit for the Animals.
6. The transport of the Animals will be arranged by the Transporter, by February 2020.
7. The Transporter is responsible for complete ground and air transport of the Animals from Prague Zoo to the Recipient.
8. The Recipient is required to ensure the Animals with adequate housing, diet, veterinary care and other necessities conducive to the well-being of the Animals.
9. The Transporter confirms to arrange all necessary transport, export and import documentation and health certificates respecting all requirements given by the importing country as reported by the Recipient.
10. Transporting vehicle which will be used is in accordance of EU veterinary and animal transport requirements.
11. The Transporter is responsible to provide the transport crates for the Animals meeting the IATA regulations. The transport crates must be agreed with the airport cargo agent at least 10 days before the date of the transport.
12. The Transporter is required to ensure the Animals with adequate housing, diet, veterinary care and other necessities conducive to the well-being of the Animals before departure to the Recipient.
13. Ground transport route and time frame: February 2020 (date will be specified later by email).

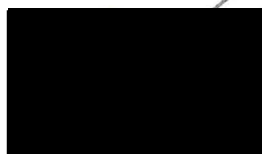


14. Air transport expected departure and time frame: February 2020 (exact date will be specified later by email).
15. The Recipient is required to cover the transport costs of the Animals (the air and ground transport, packing, loading, transport crates, pre-export and export formalities and other possible related costs) to the Transporter.
16. Upon delivery of the Animals, a hand-over certificate will be ratified. The Recipient will scan the signed hand-over certificate and will send it via e-mail to the Prague Zoo and to the Transporter within 24 hours. The Transporter will sign the hand-over-certificate on the day of pick up the Animals in Prague Zoo.
17. Recipient undertakes to make at the place of arrival all custom, veterinary and other procedures necessary for entry of the Animals into the receiving country.
18. Rights and obligations of the contracting parties that are not explicitly defined in this agreement shall be governed by relevant provision of the Civil Code of the Czech Republic. While this agreement has been executed in English, it is subject to the laws of the Czech Republic only.
19. Three originals of this Agreement are executed, one for each contracting party.
20. Any difference or dispute arising out of the interpretation and/or implementation of this Agreement shall be settled amicably through consultation and/or negotiations between the parties.
21. The Contracting Parties agree with publication of this Agreement in its entirety including personal data contained in the contract, as well as of the acts and circumstances associated with this Agreement, or with provision of information to third parties about this Agreement or the essential parts of this agreement, under the conditions defined in Act No. 106/1999, free access to information, in the version current at the date of request for information or publication, and also declare that none of the contents of the contract shall be considered as trade secret.

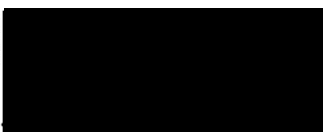
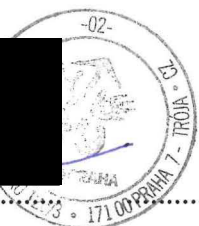
