1. INTRODUCTORY PROVISIONS

The Seller and the Buyer have entered into mandate contract on 21st September 2020, contract no. 282162/2020-ČRA, (hereinafter the “contract”).





2. SUBJECT OF THE AMENDMENT

- 2.1. The Seller and the Buyer have agreed on the following changes of the contract.
- 2.2. Provision about period of performance in Section 3 Article 1 of the contract changes as follows:
1. ***The seller undertakes to deliver the object of the purchase to the buyer by 10st December 2020.***
- 2.3. Other provisions of the contract remain unchanged.

3 FINAL PROVISIONS

- 3.1. The Parties acknowledge that this Amendment will be published in the contracts register in accordance with Act No. 340/2015 Coll., on the contracts register, as the Buyer is a liable party within the meaning of the act, and the Parties agree with the publication hereof. Publication shall be arranged by the Buyer within 30 days from signature of the Amendment by both Parties.
- 3.2. This Amendment becomes effective after its signing by duly authorized representatives of both Parties and its publication in the register of contracts.
- 3.3. This Amendment is executed in three counterparts from which two will receive the Buyer and one will receive the Seller.
