1. SUBJECT MATTER OF THE AMENDMENT

- Pursuant to the provisions of Article 12, especially par. 12.9 of the Contract, the contracting parties have agreed to amend the Supplier's bank account information. The amendment consists in addition of another bank account number of the Supplier, which shall be included in an invoice issued by the Supplier for EuroHPC JU to make a payment for the delivery of the part of the System pursuant to Par. 12.5 of the Contract.
