I. Účel daru

2. Finanční prostředky se Dárce zavazuje poukázat na účet Obdarovaného uvedený v záhlaví této smlouvy nejpozději do 30 dnů od podpisu této smlouvy.

II. Závazky Obdarovaného

1. Obdarovaný se zavazuje využít Finanční prostředky k účelům, jak bylo stanoveno v čl. I. odst. 1. této smlouvy. Na žádost Dárce je Obdarovaný povinen Dárci prokázat účel použití Daru. V případě, že Obdarovaný neprokáže na žádost Dárce účel použití Daru nebo použije Dar nebo jeho část k jinému účelu, než je stanoven v čl. I. odst. 1. této smlouvy, může Dárce od této smlouvy odstoupit a žádat vrácení Daru v plné výši včetně užitků z něj plynoucích.

III. Ostatní ustanovení

1. Smlouva se vyhotovuje ve dvou stejnopisech, z nichž obdrží každá ze zúčastněných stran jeden.
2. Smlouva nabývá platnosti dnem podpisu oběma smluvními stranami, účinnosti pak dnem zveřejnění v registru smluv dle zákona č. 340/2015 Sb., o zvláštních podmínkách účinnosti některých smluv, uveřejňování těchto smluv a o registru smluv (zákon o registru smluv). Smluvní strany výslovně sjednávají, že uveřejnění této smlouvy v registru smluv zajistí Obdarovaný.
3. V otázkách neupravených touto smlouvou platí Občanský zákoník České republiky.
4. Tato smlouva byla schválena usnesením Rady městské části Praha 20 č. RMC/76/7/1479/20 dne 6.11.2020.

From time to time, PointPark Properties s.r.o. (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
