1. INTRODUCTORY PROVISIONS

1.1. On October 22, 2018, the Contracting Parties entered into the Electronic Information Resource Agreement which defines the conditions of cooperation and rights and duties of the Contracting Parties while providing defined Materials (hereinafter referred to as the “**Agreement**”). Agreement was published in the Register of Contracts on October 24, 2018 with the ID of contract 6550503 and eventually amended by Amendment No. 1, No. 2., No. 3. , No. 4. and No. 5



1.2. The Contracting Parties execute this Amendment to modify the fees in Appendix A: Business Terms due to:

a) applicability of the conditions in Appendix D of the Agreement, paragraph “Publisher may, from time to time, cease publication of individual journals in which case the journal(s) will be removed from the NTK and the Participating Institution’s Core Collection, and the fees associated with the journal(s) will no longer be factored into the Core Collection Fee “ the Contracting Parties decided to remove Titles (Title drops) from the Core Collection of

- Charles University
- Palacký University Olomouc
- University Hospital Brno
- University Hospital Ostrava

b) reduce the Total Fee, such decrease comprises both reduction of individual Fees for years 2021 and 2022 (price freeze for year 2021) and acquisition of Backfiles for selected journal titles (extended access to years before 1997) for NTK and the Participating Institutions.

1.3. The Contracting Parties execute this Amendment to modify the journal list in Appendix E: Holdings and Collections due to the aforementioned changes.

2. SUBJECT-MATTER OF THE AMENDMENT

2.1. The Contracting Parties have agreed that Appendices A and E to the Agreement shall be modified in relation to the Participating Institution changes aforementioned in section 1.2 and 1.3 of this amendment.

3. FINAL PROVISIONS

3.1. The Amendment shall become valid on the date of signature by both Contracting Parties. The Amendment comes into effect on the date of its publication in the Register of Contracts under the conditions stipulated by Act No. 340/2015 Coll., On the Register of Contracts, as amended. The Amendment will be published by Licensee in the Register of Contracts. The Amendment contains business secrets pursuant to the provisions of Section 504 of Act No. 89/2012 Coll., the Civil Code, as amended, which will not be disclosed in the Register of contracts in accordance with provisions of Section 3, Paragraph 1 and Paragraph 2 letter b) of Act No. 340/2015 Coll. (the fees of the individual Participating Institutions).

3.2. All other provisions of the Agreement shall remain unaffected.

3.3. The Parties declare and confirm that they acted pursuant to the changes introduced by this Amendment already as of 1 January 2021. Thus, where applicable, the changes stipulated in this Amendment were applied as of 1 January 2021. Any previous performance non-compliant with this Amendment will be subsequently settled by the Parties, if necessary.

3.4. The Amendment is compiled in three counterparts in the English language, each of which has the power of an original. Suweco shall receive one counterpart and NTK shall receive two counterparts.

3.5. The Contracting Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and effect under law and each Contracting Party declares that the electronic execution is valid and effective in the jurisdiction the Contracting Party executes the Amendment.

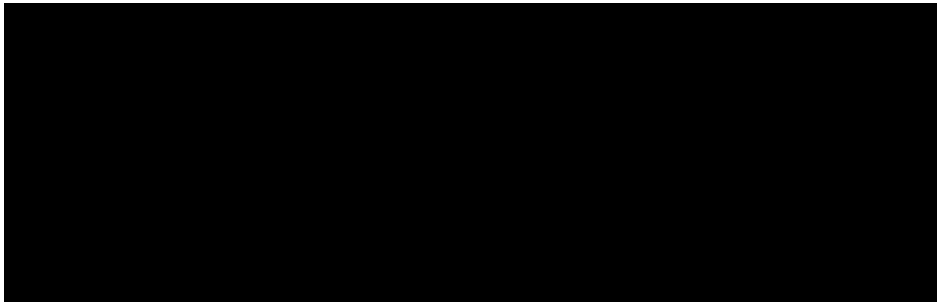

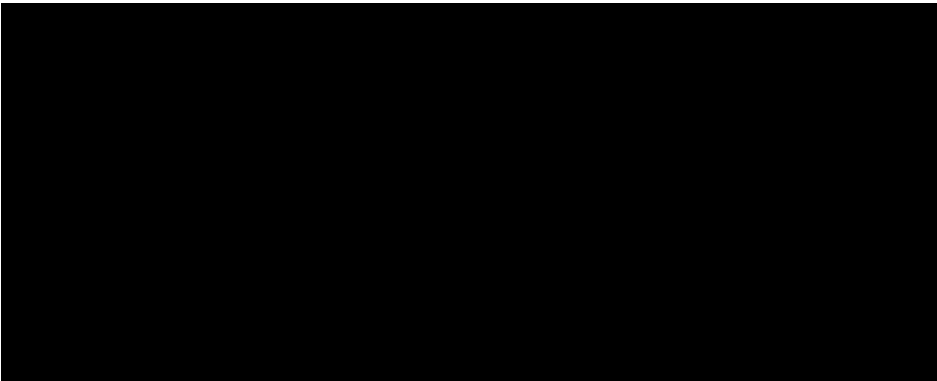
