Following procedure has been applied by the Client on the productive approval sample cards:

- 1) Personalization of the chip
  - a. Correct key diversification check
  - b. Correct electrical personalization of the chip check
  
- 2) Fully personalized samples has been checked using the application Golden Reader Tool Platinum Edition v 3.0 using following reading modes:
  - a. Standard
  - b. BAC [EAC1]
  - c. PACE [EAC1]
  - d. Autodetect

In case of PACE, both MRZ and CAN will be used to get the access to the chip.

- 3) Fully personalized samples has been checked using the STC inspection tool, which is used as a output quality check for all biometric documents produced by the Client.
- 4) Fully personalized samples has been checked using the inspection station which is used for the purpose of handover of the biometric document to the citizen, typically at municipality building.

**Following the above stated, the Client confirms that productive sample is considered to be fully functional because all checks 1) to 4) have passed smoothly without any errors or warnings. Relevant logfiles have been exported.**
