Conclude the following purchase contract below:

1. Object of the contract

1. 1. The subject of this contract is the seller's obligation to transfer the ownership of the following subject of sale and the buyer's obligation to pay the purchase price.
1. 2. For the purposes of this contract, the subject of the sale means:

2. Purchase price

2. 1. The purchase price is determined by agreement and includes shipping and VAT **318,169.50 CZK** (bywords: three hundred and eighteen thousand one hundred and fifty-nine crowns and fifty pennies).
Of which VAT is: 55,219.50 CZK
2. 2. The purchase price will be paid on the basis of an invoice, which the seller will issue and deliver to the buyer after taking over the object of sale at the destination. The invoice will be due 30 days from the date of its demonstrable delivery to the buyer.

3. Place of performance

- 3.1. Place of performance is Husinec-Řež 130, 25068 CZ

4. Sanction arrangements

- 4.1. Interest on arrears in the event that the buyer is in arrears with payment of the purchase price is 0.1% of the amount due for each day of delay.


4. 2. The seller undertakes to pay a contractual penalty of 0.1% of the total purchase price for each day of delay if the subject of sale does not deliver within 14 days of signing the contract or does not deliver properly and in working order, but not more than 10% of the purchase price.

5. Final arrangements

- 5.1. An integral part of this contract is the price offer QU-CZ-0018 and the terms and conditions of Yotta Volt.
5. 2. The contract can be changed only by agreement of the parties, in the form of written numbered amendments.
5. 3. Unless otherwise provided in this Agreement, the sale is governed by the Yotta Volt Terms and Conditions. All provisions are subject to the applicable Civil Code.
5. 4. This contract is written in two copies, one of which will be received by each of the parties. The contracts are valid at the moment of attaching the signatures of the representatives of both parties.
5. 5. The contracting parties declare that they have read the contract carefully, agree with its content and confirm this fact with their signatures.
