Article I.

Subject of the Amendment

1. On May 24th 2021, the Parties have concluded the Partnership Agreement No. 007138/2021/00 (hereinafter referred to as the "Agreement"), for the type of partnership Bronze Partner with a membership contribution of CZK 60 000 excl. VAT for a fixed term, specifically for the period from the date of execution hereof to 31st December 2021.
2. The subject of this Amendment no. 1 (hereinafter referred to as the "Amendment") are the following changes to the Contract.
3. The Parties have agreed to change the type of partnership to **Silver Partner** with a membership contribution of **CZK 140 000 excl. VAT**.
4. The provisions of Article II. of the Agreement are now worded as follows:

Type of Partnership and Membership Contribution

1. *The Partner hereunder becomes:*

2. For the membership, the Partner agrees to pay a membership contribution in the amount of:
CZK 140 000 excl. VAT

**Article II.
Final Provisions**

1. Other provisions of the Agreement remain unchanged.
2. By execution hereof, the Parties confirm that they are aware that this Amendment is subject to publication pursuant to Act No. 340/2015 Coll., on the Contracts Register, as amended. Its publication in the Contracts Register shall be ensured by the FIT BUT.
3. This Amendment enters into force upon its execution by both Parties. The Parties acknowledge that this Amendment enters into effect not earlier than on the date of publication of the Amendment in accordance with the Contracts Register Act.
4. The Parties declare that they do not consider the facts specified in this Amendment to be commercial secrets and grant their consent to their use and publication without any further conditions.
5. This Amendment is executed in two (2) original counterparts, one for each of the Parties.
6. Having carefully read this Amendment, the Parties declare that they agree with its contents and that the Amendment has been drawn up on the basis of true information and their true and free will, and not under duress and strikingly unfavorable conditions.
