

The Parties hereby have agreed to make changes on the Partnership Agreement concluded on 14th December 2020 (hereinafter referred to as "Agreement") as follows:

Article 1 Subject matter of the Amendment

For the avoidance of all doubt, the Parties have agreed to amend the Agreement, with regard to the rules for reporting costs, with the following provision:

The payments from the Project Promoter to the project partners are made in CZK.

The Norwegian Partner (Stiftelsen Det norske Skogfrøverk) prepares the Payment Application in CZK using for settlement the average NOK exchange rate of the daily exchange rates published by the European Central Bank, calculated over the corresponding reporting period. Article 2 Final provisions

This Amendment shall take force at the moment of sign by the last Party and effect on the Effective Date.


The other provisions of the Agreement not specified in this Amendment remains unaffected.
