hereinafter referred to as "the coordinator",

and the other beneficiaries, listed in the above mentioned Grant Agreement (hereinafter referred to as "the Agreement"),

hereinafter referred to collectively as "the beneficiaries",

Having regard to the mandate(s) attached to the Agreement, which allow(s) the coordinator to request the amendment of the latter,

Whereas by letter of 14/09/2020 the coordinator has requested an amendment of the Agreement,

Whereas the Agency agrees to amend the Agreement,

As a consequence, the Agreement is modified as follows:

ARTICLE I

i. The following entities withdraw as co-beneficiaries with effect from the date specified in the following table:

iii. ARTICLE I.2 - ENTRY INTO FORCE AND IMPLEMENTATION PERIOD OF THE AGREEMENT SHALL READ AS FOLLOWS:

I.2.1 The Agreement enters into force on the date on which the last party signs it.

I.2.2 The *action* runs as of 01/08/2017 ("the starting date of the action") and ends on 31/12/2021.

Please note that the new repartition of costs between partners is taken into account by our services.


ARTICLE II
