The contracting parties hereby conclude the present Annexe No. 1 to the above-designated Contract:

1. Article I is changed as follows: The contracting parties undertake to co-operate in the recruitment of foreign self-paying students for **regular studies** of accredited study programmes of the Faculty of Medicine of Masaryk University **in its English language programmes of Dentistry, General Medicine and Physiotherapy.**
2. Article II, par. 2.5 is changed as follows: For each student enrolled for studies from the academic year 2015/2016 by means of Agency, The Faculty shall pay to Agency a commission in the amount of
- 15 % from the amount of money actually paid as a tuition fee for the first-year study at The Faculty by each General Medicine or Dentistry student recruited by Agency,

- 10 % from the amount of money actually paid as a tuition fee for the first-year study at The Faculty by each Physiotherapy student recruited by Agency,

3. Article II, par. 2.10 is changed as follows: The tuition fee for the discipline of "Physiotherapy" is **CZK 195, 000.00** per year. The tuition fees do not comprise costs of accommodation, food, insurance of students, and the like. Such expenses have to be carried by the students themselves." **The other parts of the Contract remain unchanged**
4. This Annexe comes into force and effect by the date of its signing by the Contractual Parties and is an integral part of the aforementioned Contract
5. This Annexe is printed in three copies in the English language. Masaryk university shall keep two copies the Agency shall keep one copy.
